Re: Tolling Request for Construction Permit BNPFT-20130328ATN

Dear Ms. Dortch:

On January 27, 2016, E-String Wireless, Ltd. ("E-String") filed an assignment application with the Federal Communications Commission seeking to assign Construction Permit BNPFT-20130328ATN for unbuilt FM Translator Station K229CG at Emporia, Kansas (hereinafter the "Construction Permit") to Salem Media of Illinois, LLC ("Salem") (BAPFT-20160127ADZ). Salem subsequently filed a minor change modification application for K229CG on January 29, 2016 (BMPFT-20160129AXR), which was amended February 4, 2016. The purpose of the modification is to allow Salem to rebroadcast KCRO (AM), Omaha, Nebraska. Upon grant of the modification application, Salem will build the modified translator promptly.

The Construction Permit currently is scheduled to expire on May 3, 2016. E-String accordingly requests that the Construction Permit be tolled pursuant to Footnote 36 of the FCC's October 23, 2015 "AM Revitalization" Order, FCC 15-142, for six months from the later of the grant of the above-referenced assignment application or the above-referenced modification application.


