### **Advancement of Educational Program**

The University of Central Florida ("UCF"), proposed assignee of Station WMFE-TV, Orlando, Florida, respectfully submits the following explanation of its educational objective and the manner in which the station will be used for the advancement of an educational program that will further that objective, in accordance with Section 73.621 of the FCC's Rules, 47 C.F.R. § 73.621.

UCF is a public, multi-campus metropolitan research university with a main campus located in Orlando, Florida. Originally established by an act of the Florida state legislature in 1963, UCF now offers more than 200 degree programs. With more than 58,000 students at its main campus and 10 regional campuses, UCF is the largest university in Florida, and the second largest in the country. UCF's mission is to anchor Central Florida in meeting its economic, cultural, intellectual, environmental, and societal needs by providing high-quality, broad-based education and experience-based learning; pioneering scholarship and impactful research; enriched student development and leadership growth; and highly relevant continuing education and public service initiatives that address pressing local, state, national, and international issues in support of the global community.

UCF's planned operation of WMFE-TV will serve the educational needs of the Orlando community, as well as advancing UCF's educational objectives and missions. UCF shall furnish a nonprofit and noncommercial television broadcast service over WMFE-TV, and plans to broadcast traditional Public Broadcasting Service ("PBS") programming on the station's primary stream, including educational children's programming, news and public affairs programming, history and science programming, and cultural programming that explores music, theater, dance, and art, as well as local and UCF-related programming. UCF will work to ensure that the high quality noncommercial educational programs, including children's programs, news, performing arts, and/or public affairs programs, broadcast over WMFE-TV will be responsive to issues of concern to viewers in its local community.

For these reasons, UCF respectfully submits and certifies, pursuant to Section 73.621(a) of the FCC's Rules, that the station will be used primarily to serve the educational needs of the community; for the advancement of educational programs; and to furnish a nonprofit and noncommercial television broadcast service. UCF is accredited by the Southern Association of Colleges and Schools Commission on Colleges to award degrees at the baccalaureate, master's, and doctoral levels.
