TIMESHARE AGREEMENT

Reach For The Top, Inc. grantee of Low Power FM Construction Permit on Channel 256 / 99.1 FM (BNPL-20131113BUG) hereby enters a voluntary timeshare agreement with LPFM MX Group 27 applicants Future Roots (BNPL-20131114BDZ), Echo Park Film Center (BNPL-20131114BEK), and Machine Project (BNPL-20131114BKP). This proposed timeshare supersedes all previous agreements submitted by above applicants within LPFM MX Groups 40 ¹ and 27².

- 1. Schedule.** The Parties shall each broadcast on Channel 256 in accordance with the schedule attached hereto as Exhibit A. The Parties agree that in accordance with FCC rules §73.875(c)(3) any change in said broadcast schedule must be agreed to in advance by all parties in writing and said document shall be filed with the FCC prior to the date of any schedule change going into effect.

¹ Per FCC Public Notice Report No. 48344, *Reach For The Top, Inc.* previously filed to timeshare with *Strategic International Ministries* for LPFM MX Group #40. On December 16, 2014, the Commission subsequently granted *Strategic's* application BMPL-20141117ADQ requesting unlimited hours per separation of 35.9 kilometers from *Reach*. This Agreement supersedes *Reach's* previous filing and updates allocation of time-shared hours.

² MX Group 27 applicants *Echo Park Film Center*, *Future Roots* and *Machine Project* previously co-signed onto a timeshare with *Craft & Folk Art Museum* (BNPL-20131114BDA) and *Materials & Applications* (BNPL-20131114BHL). *Craft & Materials* are not parties to this Agreement however, but have separately filed amendments as part of a mediated universal settlement of LPFM MX Group 27.

- 2. Timeshare requirements.** Per 47 C.F.R. § 73.872 (c), the Parties each agree to broadcast programming for more than 10 hours weekly in accordance with the schedule.
- 3. Organizational Standing.** Each applicant represents that it is duly organized not for profit or educational organization existing and in good standing.
- 4. Confidentiality.** To the extent that any information disclosed to any of the Parties hereto which is designated as confidential by the disclosing Party shall be so treated and shall not be disclosed other than to the Parties boards, attorneys or authorized representatives on a need-to-know basis.


