OTHER AUTHORIZATIONS

As set forth in Exhibit 10, this application seeks consent to the transfer of control or assignment of certain licenses indirectly controlled by The Walt Disney Company pursuant to an internal reorganization. Set forth in Section I below are the broadcast interests of The Walt Disney Company under the current ownership structure.¹ Section II depicts these exact same broadcast interests as they will be held post-reorganization under the proposed ownership structure.
