**Subject:** Salem Media of Hawaii, Inc.'s request for STA to reduce power

Dear Mr. Shuldiner and Mr. Bradshaw:

On behalf of Salem Media of Hawaii, Inc. ("Salem"), licensee of radio stations KAIM-FM (10950), KHCM(FM) (34620), KGU(AM) (53705), KGU-FM (641), KKOL-FM (70384), and KHNR(AM) (16742) (the "Salem Hawaii Stations"), I am writing to request special temporary authority to reduce the Salem Hawaii Stations' power by 50% for 90 days effective as soon as possible, as follows:

- KAIM-FM (10950): from 100kW to 50kW
- KHCM(FM) (34620): from 80kW to 40kW
- KGU(AM) (53705): from 10kW to STA 5kW
- KGU-FM (641): from 100kW to 50kW
- KKOL-FM (70384): from 100kW to 50kW
- KHNR(AM) (16742): from 10kW to STA 5KW

With the exception of KKOL-FM, whose community of license is Aiea, HI, the Salem Hawaii Stations' communities of license is located in Honolulu, HI. The granting of this request will allow Salem to save significant amounts on its electric bill and offset losses in revenue we are experiencing due to the COVID-19 pandemic. The Salem Hawaii Stations will be able to continue to serve the majority of its service area with this power reduction.

Thank you for allowing broadcasters to seek this much needed relief through an expedited, informal STA process. If you have any questions or need further information, please do not hesitate to contact me.
