Additionally, in the interest of complete disclosure, it should be noted that the mother of Marshall W. Pagon is married to W.W. Keen Butcher, the Chief Executive Officer and Chairman of the Board of Managers of KB Prime Media, L.L.C. ("KB Prime"). KB Prime is the licensee of WFXU(TV), Live Oak, Florida, WPME(TV), Lewiston, Maine and WSWB(TV), Scranton, Pennsylvania, and the permittee of WTLF(TV), Tallahassee, Florida and WGMP(TV), Gulf Shores, Alabama.

PCC or its related entities hold an option to acquire any or all of the membership interests and/or assets of KB Prime. However, this arrangement has been approved by the Commission on two occasions. See FCC File Nos.
