

Non-Preclusion Study

This Non-Preclusion Study ("NPS") is being conducted for Georgia-Carolina Radiocasting, LLC, applicant for Channel 288D, Waynesville, NC, Facility ID Number 155786. The applicant was selected as a "Singleton" and wishes to change the proposed translator facility. There are two nearby Arbitron markets, Asheville, NC and Greenville-Spartanburg, SC. Both are Non-Spectrum Limited markets.

With regard to the Local Community Radio Act of 2010 ("LCRA"), an examination was made to determine if the desired translator change would have any effect on the ability to construct a new LPFM in both of these markets. The program LPFM6 (December 2012 version) was used in this analysis. Attached is the program setup and condensed results.

The subject translator is on Channel 288. The search results indicate zero LPFM opportunities on this channel. There are LPFM opportunities on first adjacent Channel 287 and second adjacent Channel 286. Each of the points listed in the attached printouts are at distances greater than the required separation (28 KM for first adjacencies and 21 KM for second adjacencies). It is therefore our conclusion that the requested minor change of this subject translator, Facility ID 155786, is in compliance with the LCRA and does not impact any future LPFM facilities.




