Notice of Operation at Reduced Power**


Dear Ms. Dortch:

Pursuant to Section 73.1560(d) of the Commission's Rules, New Hampshire Gospel Radio, Inc., licensee of Noncommercial Education Station WVNH (FM), Facility Id. No. 8698, Concord, New Hampshire, herein notifies the Commission that WVNH is operating at reduced power pending the completion of an overhaul of the station's transmitter. The station is currently operating with an ERP of 388 watts instead of 650 watts as specified in its license. The operation of WVNH at reduced power commenced June 21, 2012.

In the event WVNH does not return to full-power on or before July 21, a request for Special Temporary Authority to operate at reduced power shall be filed.
