**Description:** OPERATIONS AT REDUCED POWER

AS A RESULT OF THE TV REPACK, THE TOWER WHICH WOAY IS USING HAS BEEN REDUCED IN HEIGHT BY 50 FEET. AS A RESULT OF THIS REDUCTION, WOAY CAN ONLY OPERATE AT 7KW INSTEAD OF THE 10KW AUTHORIZED. THE LICENSEE IS CURRENTLY CONSULTING WITH ITS ENGINEERS TO DETERMINE WHAT CAN BE DONE TO ENABLE WOAY THE ABILITY TO RETURN TO FULL POWER, BUT AT THIS TIME THE STATION MUST OPERATE A REDUCED POWER. UNDER THE CIRCUMSTANCES, THE LICENSEE RESPECTFULLY REQUESTS AUTHORITY TO OPERATE AT REDUCED POWER FOR 180 DAYS.

**Description:** REASONS FOR FURTHER STA EXTENSION

AS PREVIOUSLY ADVISED, DUE TO THE TV RE-PACK, THE WOAY TOWER HAS BEEN REDUCED IN HEIGHT BY 50 FEET. AS A RESULT OF REDUCTION, WOAY CAN ONLY OPERATE AT 7KW INSTEAD OF THE 10KW AUTHORIZED. THE LICENSEE CONTRACTED WITH MUNN-REESE TO PREPARE A CP APPLICATION TO ADDRESS THE CHANGE IN POWER, LICENSEE SENT MUNN-REESE MEASUREMENTS TO FACILITATE THE PREPARATION OF THE CP MOD BUT MUNN-REESE REQUIRED BOTH ADDITIONAL MEASUREMENTS WITH EQUIPMENT NOT READILY AVAILABLE AND ACCESS TO AM RECORDS MAINTAINED IN THE COMMISSION'S MEDIA BUREAU ENGINEERING FILES LOCATED EITHER AT THE COMMISSION OR AT OFFSITE STORAGE FACILITY. AS NOTED PREVIOUSLY, WOAY HAS REPLACED MUNN-REESE WITH CHARLES M. ANDERSON AS CONSULTING ENGINEER TO MAKE THE NECESSARY MEASUREMENTS. SUBSEQUENT TO THE LAST STA EXTENSION, THE NECESSARY CALIBRATION OF FIELD STRENGTH METER WAS COMPLETED BY POTOMAC INSTRUMENTS IN DECEMBER AND MR. ANDERSON HAS INDICATED THAT DUE TO DAYLIGHT HOURS, THE NEEDED MEASUREMENTS CAN BE TAKEN IN MAY 2023. AS THAT CANNOT BE COMPLETED BY THE CURRENT STA EXPIRATION DATE OF FEBRUARY 14, 2023, AN ADDITIONAL 180 DAYS IS REQUESTED TO ACCOMPLISH THESE TASKS AND GET THE CP APPLICATION ON FILE.
