

**Description of Transaction and Changes in Interests**

This and other concurrently filed applications seek the consent of the Commission for the *pro forma* assignment of licenses in connection with the internal reorganization of entities under the control of Dean Goodman. Upon consummation of the restructuring proposed in this application, the indicated licenses would be assigned between the entities listed in *Table 1: Current Licensees and Proposed Assignees* below. The restructuring transaction qualifies as a *pro forma* assignment of licenses because, as described in this exhibit, Dean Goodman currently holds a controlling interest in all of the specified licensees and will continue to do so after consummation of these transactions. This exhibit includes descriptions of the ownership of the licensees before and after the restructuring and the steps involved in the transaction.

**Current Ownership:**


*DeanRadio.TV Companies:* Dean Goodman, a United States citizen, currently is the sole member of Dean Radio.TV Company – Grinnell, LLC and Dean Radio.TV Company – Newton, LLC, both of which are Florida limited liability companies. Dean Goodman also controls GoodRadio.TV, LLC, a member-controlled Florida limited liability company, which, in turn, is the sole member of Dean Radio.TV Company – Fairfield, LLC, also a Florida limited liability company.

*GoodRadio.TV, LLC:* Dean Goodman is the sole manager of and holds all of the voting interests and 40.00 percent of the equity interests in GoodRadio.TV, LLC. GoodRadio.TV, LLC is a member controlled limited liability corporation, and accordingly has no board of directors. Legacy Management Group, Inc., a Florida corporation, is a nonvoting member of and holds a 10.74 percent equity interest in GoodRadio.TV, LLC. Carl Hirsch, a United States Citizen, is the President, CEO, and sole shareholder of Legacy Management Group, Inc. Edward O. Fritts, a United States citizen, is a nonvoting member of and holds a 3.33 percent equity interest in GoodRadio.TV, LLC. Christine Goodman, a United States citizen, is a nonvoting member of and holds a 13.33 percent equity interest in GoodRadio.TV, LLC. W. Lawrence Patrick and Susan K. Patrick, both United States citizens, are nonvoting members of and each holds a 16.3 percent equity interest in GoodRadio.TV, LLC. The ownership of GoodRadio.TV, LLC will not change as a result of the consummation of the transactions proposed in this application.

*Figure 1: Current Ownership* below depicts the current ownership structure of these Dean Radio.TV companies and GoodRadio.TV, LLC. The address and citizenship of each interest holder is also included below in *Table 4: Address and Citizenship of Interest Holders*.

**Transaction Steps:**

The proposed transaction would be accomplished by the following steps. Since all of these steps would occur instantaneously at a single closing in a continuous, uninterrupted series, only one consent is required. *See, e.g., John H. Phipps, Inc.*, 11 FCC Rcd 13053, ¶¶ 8-9 (1996). Throughout these steps, Dean Goodman would retain control of each specified FCC license.

- A new holding company, GoodRadio.TV Holdings, LLC, would be inserted between GoodRadio.TV, LLC and Dean Radio.TV Company – Fairfield, LLC and GoodRadio.TV Missouri, LLC.
- Dean Goodman would contribute his entire interest in Dean Radio.TV Company – Newton, LLC and Dean Radio.TV Company – Grinnell, LLC to GoodRadio.TV, LLC, which, in turn, would contribute those interests to GoodRadio.TV Holdings, LLC.
- Dean Radio.TV Company – Grinnell, LLC and Dean Radio.TV Company – Newton, LLC would become wholly owned subsidiaries of GoodRadio.TV Holdings, LLC. As a result, GoodRadio.TV Holdings, LLC would have four direct, wholly owned subsidiaries (the “Operating Companies”):
  - Dean Radio.TV Company – Grinnell, LLC
  - Dean Radio.TV Company – Newton, LLC
  - Dean Radio.TV Company – Fairfield, LLC
  - GoodRadio.TV Missouri, LLC
- Each of the Operating Companies would hold all of the issued and outstanding capital stock of certain license subsidiaries, as shown in *Table 2: New License Subsidiaries* below:

- Subject to receipt of FCC consent, at the closing of the proposed reorganization, the licenses currently held by Dean Radio.TV Company – Grinnell, LLC; Dean Radio.TV Company – Newton, LLC; Dean Radio.TV Company – Fairfield, LLC; and GoodRadio.TV, LLC would be assigned to the license subsidiaries (the “License Subsidiaries”) as set forth above in *Table 1: Current Licensees and Proposed Assignees*.

**Proposed Ownership:**


Following consummation of the proposed transactions, GoodRadio.TV, LLC would indirectly own and control each of the License Subsidiaries. The current ownership structure of GoodRadio.TV, LLC would not change. Dean Goodman would continue to be the sole manager and voting member of GoodRadio.TV, LLC.

GoodRadio.TV, LLC would in turn be the sole member of GoodRadio.TV Holdings, LLC. GoodRadio.TV Holdings, LLC, would be the sole member of each of Dean Radio.TV Company – Grinnell, LLC, Dean Radio.TV Company – Newton, LLC, Dean Radio.TV Company – Fairfield, LLC, and GoodRadio.TV – Missouri, LLC. Dean Radio.TV Company – Grinnell, LLC would be the sole member of Grinnell License Co, LLC. Dean Radio.TV Company – Newton, LLC would be the sole member of Newton License Co, LLC. Dean Radio.TV Company – Fairfield, LLC would be the sole member of Fairfield License Co, LLC. GoodRadio.TV – Missouri, LLC would be the sole member of Moberly/Macon License Co, LLC; Cameron/Bethany License Co, LLC; Festus/Farmington License Co, LLC; and, Waynesville/Lebanon License Co, LLC. *Table 1: Current Licensees and Proposed Assignees* indicates the station licenses that would be assigned to each respective License Subsidiary. The proposed ownership structure is depicted graphically in *Figure 2: Proposed Ownership* below.

As demonstrated in this Exhibit 10, the internal restructuring proposed in this application would not constitute a substantial change in ownership or control, and qualifies for *pro forma* treatment under the FCC's rules and policies.
