MULTIPLE OWNERSHIP COMPLIANCE

The transfer of control proposed in the instant application complies with the Commission's multiple ownership rules. Station KZBV(FM), Carmel Valley, California, Fac. ID 176698 is a noncommercial educational ("NCE") station located in Monterey County, California, which in turn is located inside the Nielsen Monterey-Salinas-Santa Cruz Metro Market. A brief survey of some of the larger cities within this metro market show that there are at least 38 full power radio stations licensed within the market. These stations are listed on the following page.

Carl J. Auel and Janice Crothers, the President and Vice President of Aware FM, Inc., respectively, have attributable interests in Monterey County Broadcasters, Inc., which is the licensee of commercial AM station KKMC, Gonzales, California, Fac. ID 43603. Station KKMC is also located in the Monterey-Salinas-Santa Cruz Metro Market.

James E. Auel, the Secretary and Treasurer of Aware FM, Inc., has attributable interests in Santa Cruz Educational Broadcasting Foundation, which is the licensee of noncommercial FM station KFER, Santa Cruz, California, Fac. ID 59064. Station KFER is also located in the Monterey-Salinas-Santa Cruz Metro Market.

After the transfer purposed herein, Carl J. Auel and Mrs. Crothers will have attributable interests in one commercial AM station and one NCE FM station within the Monterey-Salinas-Santa Cruz Metro Market. James E. Auel will have attributable interests in two NCE FM stations in the market. Such attributable interests are permissible under the Commission's rules. See 47 C.F.R. §§ 73.3555(a)(ii) (ownership of no more than 7 commercial radio stations in total and no more than 4 commercial stations in the same service in a market with between 30 and 44 commercial and NCE radio stations) and 73.3555(a)(iv) (ownership of no more than 5 commercial radio stations in total and not more than 3 commercial stations in the same service in a market with 14 or fewer commercial and NCE radio stations; provided that no attributable interests in more than 50% of the commercial and NCE radio stations in such market, unless the combination is limited to one AM and one FM station).

Diane M. Fite does not have any attributable interests apart from her interests in Aware FM, Inc.
