Multiple Ownership Showing

Sea-Comm, Inc., the proposed assignee under this application, currently owns three radio stations: WKXB(FM) Burgaw, North Carolina; WSFM(FM) Southport, North Carolina; and WBNE(FM) Wrightsville Beach, North Carolina. The city grade contours of those three stations, together with the city grade contours of stations WLTT(FM) and WCCA(FM), Shallotte, North Carolina, the stations proposed to be acquired hereby, are shown on Exhibit 15-A hereto.


As shown on Exhibit 15-B, the proposed acquisition of radio stations WLTT(FM) and WCCA(FM) by Sea-Comm, Inc. would create a new market for purposes of the Commission's local radio multiple ownership rules, which market consists of four FM stations: WKXB(FM), WSFM(FM), WLTT(FM), and WCCA(FM). The city grade contour of Sea-Comm's station WBNE(FM) does not overlap with the contours of the two stations proposed to be acquired and is therefore not included in this analysis.

Exhibit 15-C shows the outer city grade contour of stations WKXB(FM), WSFM(FM), and WLTT(FM); *i.e.*, the contour of the relevant market. Exhibit 15-D shows the transmitter site locations of seventeen commercial radio stations, including the transmitter sites for the four stations which define the relevant market. Because the transmitter sites of those seventeen stations are located within the contour of the relevant market, clearly the city grade contours of each of those stations overlap with the contour of the market and the stations should therefore be included in the market for purposes of the multiple ownership rule. In addition, Exhibit 15-D shows the transmitter site locations of six other commercial stations which sites, while not located within the market contour, are geographically close enough the market contour to indicate that the city grade contours of those stations would also overlap with the market contour. Exhibit 15-E contains a list of all stations identified herein as being in the market.¹

Pursuant to Section 73.3555(a)(1)(iii) of the Commission's Rules, in a radio market with between 15 and 29 (inclusive) commercial radio stations, a party may own up to 6 commercial radio stations, not more than 4 of which are in the same service. As demonstrated above, the proposed assignment would result in Sea-Comm, Inc. owning four FM stations in a market with more than 15 commercial radio stations, and therefore complies with Section 73.3555(a) of the Commission's Rules.

¹ Sea-Comm, Inc. has not attempted to identify each commercial radio station in the market, and undoubtedly there are other stations not shown herein which are located in the market.



Sea-Comm Radio Market and Station Count


