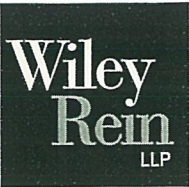

Dear Ms. Dortch:

Black Media Works, Inc. ("BMW"), permittee of FM translator Station W260CL, West Palm Beach, Florida, hereby requests a tolling waiver (47 CFR §1.3 and §73.3598) of the construction deadline for this permit pursuant to Note 36 in the *First Report and Order, Further Notice of Proposed Rule Making and Notice of Inquiry* in MB Docket No. 13-249, *Revitalization of the AM Radio Service* 30 FCC Rcd 12145 (2015). Note 36 states that waivers of the Auction 83 FM translator permit deadlines are "presumptively in the public interest for applicants participating in one of the modification windows, provided that the AM station licensee proposing to use the FM translator for rebroadcasting its AM station commits to prompt FM translator station construction and initiation of broadcast operations."

Station W260CL has a permit that was granted as a result of the Auction 83 window filings (see BNPFT-20030314AEF, BNPFT-20130805ACD). This permit will expire on November 25, 2016. BMW has filed an application in the 250 mile window to relocate the translator (BMPFT-20160129APY) so that it can rebroadcast an AM station (WWBC) as contemplated in the AM Revitalization Order. BMW has a rebroadcast agreement with the licensee of Station WWBC. BMW commits to promptly constructing and initiating operation of the translator once the pending modification application is granted. BMW's Chairman has provided a Certification statement for this purpose.

Accordingly, BMW respectfully requests a waiver of 47 CFR §1.3 and §73.3598 to toll the construction deadline of the permit for Station W260CL (BNPFT-

201300805ACD) until processing of the pending modification application filed in the 250 mile window is complete.


