

OTHER BROADCAST INTERESTS

LC Media, LP

LC Media, LP ("LC Media"), a Delaware limited partnership, is the proposed assignee of KDES-FM, Palm Springs, California. LC Media owns no other broadcast interests.

The general partner of LC Media is LC Media, LLC (1%). The limited partners are: Roy Laughlin (9%), Warren Chang (6%), Warren Investments, LLC (24%)("Warren Investments"), Rosetree Partners (30%) ("Rosetree"), Gold Coast Broadcasting, LLC (30%)("Gold Coast").

LC Media, LLC has the following 4 members: Roy Laughlin (10%), Warren Chang (6%) Warren Investments (24%), Rosetree (30%) and Gold Coast (30%).

Roy Laughlin has a 5% interest, in Rincon Broadcasting HC LLC ("RBHC"), which in turn wholly owns Rincon Broadcasting LS LLC ("RBLS"), and their broadcast interests are set forth below. Roy Laughlin has no other attributable broadcast interests.

Warren Investments has the following members: Warren Chang (35% ownership/50% voting), Haesun Koo (35% ownership/50% voting), Trust FBO Niki Chang (15% ownership - Niki Chang, sole beneficiary) and Trust FBO Dina Chang (15% ownership - Dina Chang, sole beneficiary). Warren Investments, its members, and the trust beneficiaries do not have any broadcast interests.

The general partner of Rosetree is Saul Rosenzweig (2% ownership/ 100% voting). The limited partners are: Davy Rosenzweig (49% ownership) and Laurance Rosenzweig (49% ownership). Neither Rosetree nor its members have any broadcast interests.
