

MASTER LIST AGREEMENT

THIS MASTER LIST AGREEMENT (this "Agreement") is made and entered into as of this 3rd day of February, 2006 by and between Horizon Christian Fellowship, a California not-for-profit corporation ("Buyer"), and Edgewater Broadcasting, Inc., an Idaho not-for-profit corporation ("EB").

Recitals

WHEREAS, EB and Buyer entered into that certain Assignment Agreement dated March 3, 2005 providing for EB to assign and Buyer to Purchase certain Construction Permits for FM translators (the "EB Assignment Agreement");

WHEREAS, EB and Buyer desire to amend and restate the EB Assignment Agreement as specified herein;

WHEREAS EB, has been granted certain construction permits by the Federal Communications Commission ("FCC") for new FM translators (the "Construction Permits");

WHEREAS, Buyer would like to obtain the Construction Permits on the terms and conditions specified herein;

WHEREAS, Prior FCC approval for the transactions contemplated hereunder is required.

Agreement

IN CONSIDERATION OF THE MUTUAL PROMISES CONTAINED HEREIN, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto, intending to be legally bound, do hereby cancel and nullify the EB Assignment Agreement and agree instead as follows:

1. The Construction Permits. The parties agree that Schedule 1 hereto is the list of Construction Permits available for purchase by Buyer. The Parties further agree that from time to time the Parties shall cooperate to agree upon a set of construction permits among the Construction Permits listed on Schedule 1 (a "CP Group") to be assigned to Buyer at a given time and at that time will execute an agreement (an "Assignment Agreement") in the form of Schedule 2 hereto pertaining to each such CP Group. .

2. Purchase Price. The Purchase Price for each construction permit in a given CP Group shall be Seven Thousand Four Hundred and Thirty-Three dollars (\$7,433.00). Notwithstanding the foregoing, Buyer shall purchase a minimum number of construction permits between the instant transaction with EB and the Master List Agreement dated as of a date even herewith between Buyer and Radio Assist Ministry, Inc. from among the

Construction Permits in both agreements such that the total number of construction permits purchased is not less than two-hundred and sixty-six (266) construction permits total. Four (4) other construction permits, each marked with an asterisk on Schedule 1, are being donated to Buyer.

3. Deposits. Concurrently with execution of the EB Assignment Agreement, Buyer paid EB an initial deposit in the amount of Twenty Five Thousand Dollars (\$25,000.00). Additional deposits totaling Two Hundred Eighty Thousand Dollars (\$280,000.00) have been have been paid by Buyer to EB under the EB Assignment Agreement. Buyer will pay EB two additional deposits of Ten Thousand Dollars (\$10,000.00) each on February 6, 2006 and March 1, 2006, bringing the total deposits made under the EB Assignment Agreement and this Agreement to Three Hundred and Twenty-Five Thousand Dollars (\$325,000.00).

4. Closings. The closings shall be in accordance with each Assignment Agreement for the given CP Group. At closing, and taking into account the \$325,000.00 deposits made under the EB Assignment Agreement and this Agreement, Buyer shall pay to EB by wire transfer as directed by EB the amount of Four Thousand Three Hundred and Thirty-Eight Dollars (\$4,338.00), which shall be considered payment in full for each construction permit in the CP Group closing.

5. Miscellaneous. This Master List Agreement shall represent the entire agreement of the parties with respect to the subject matter hereof and supersedes any prior agreement, written or oral, with respect thereto, including specifically the EB Assignment Agreement. This Agreement may be amended only in writing by an instrument duly executed by both parties. This Agreement is to be construed and enforced under the laws of Idaho. Venue for any action brought to enforce this Agreement is exclusively in the federal or state courts located in the State of Idaho. This Agreement may be executed in counterparts. The undersigned represent and warrant that, respectively, they have received authority to sign this Agreement and to legally bind their respective corporations to perform all of the terms hereof.
