Dear Peter:

On behalf of Capstar TX LLC (“Capstar”), the licensee of WUCS(FM), 97.9 MHz, Windsor Locks, Connecticut, FCC Facility ID No. 46965, this letter is to provide notice to your client, Danbury Community Radio, Inc. (“DCRI”), as licensee of FM Translator W250AA, 97.9 MHz, Naugatuck, etc., Connecticut, FCC Facility ID No. 15397 (the “Translator”), that the Translator is causing interference to the direct reception by regular listeners of WUCS(FM), which Capstar expects DCRI to immediately resolve.

Attached are three representative complaints of interference from *bona fide* regular listeners of WUCS(FM), along with a map showing the locations of the interference complaints. As DCRI may know, Section 74.1203(a) of the rules of the Federal Communications Commission (the “FCC”), require an FM translator to cease operation on the basis of even a single interference complaint. Given the multiple complaints, their geographic diversity and the co-channel operation of the Translator to WUCS(FM), individual listener remedial measures would not be expected to eliminate the interference problems. Consequently, Capstar expects DCRI to immediately cease operating the Translator on 97.9 MHz, and so notify Capstar and the FCC. Failure to swiftly rectify interference to the listeners of WUCS(FM) will result in Capstar taking this matter to the FCC.

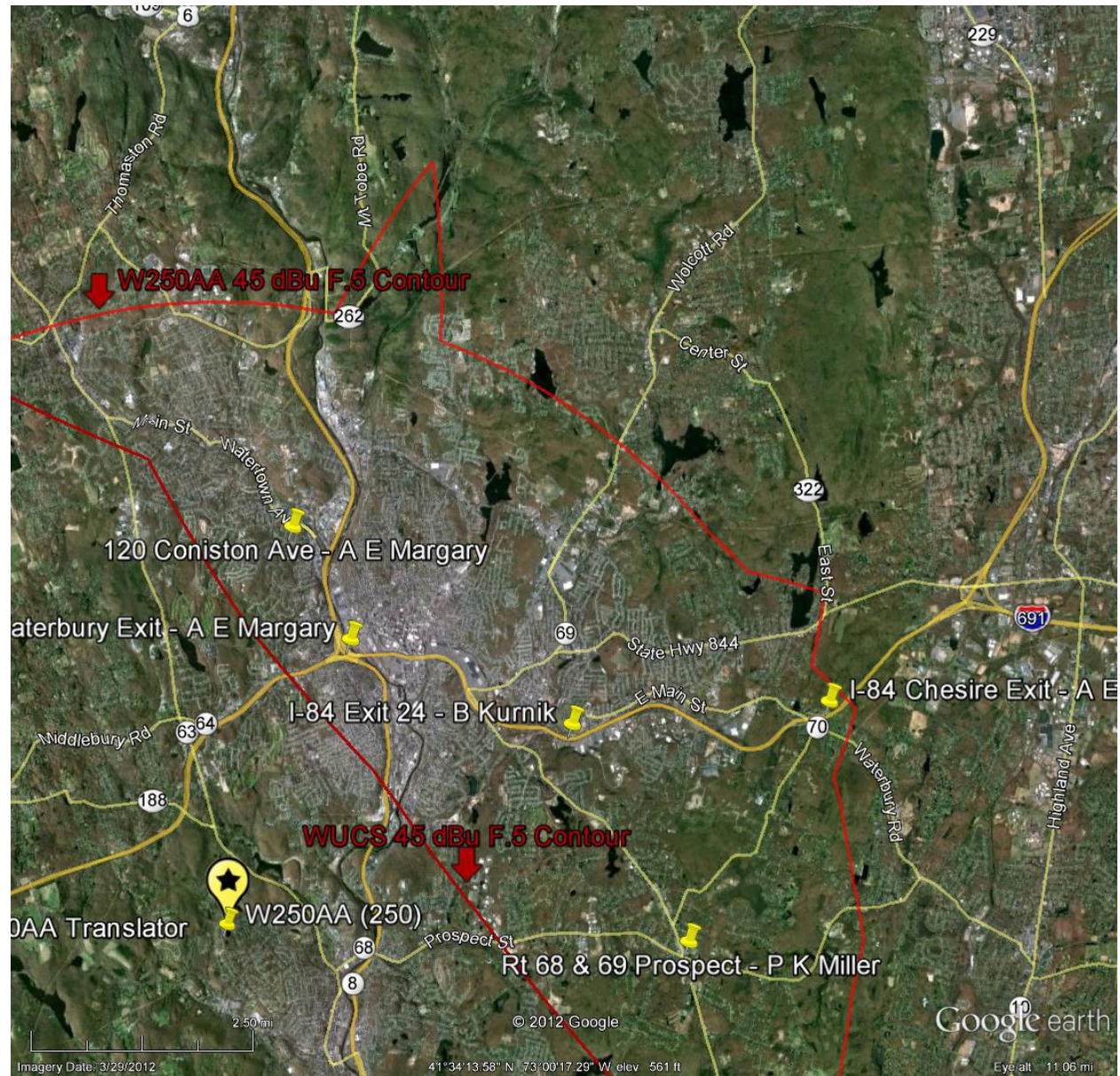

to 1300 AM station(ESPN New Haven)I still wouldn't get it because the signal is too weak, it
has always been that way. (1410 was weak as well, and Waterbury never got both signals back
then. Now all three don't make it to Waterbury) I look forward to the day this problem is
resolved.
