

POWER OF ATTORNEY

APPEARING

As Party of the First Part: Ruth Evangeline Román López, of legal age, married to Julio Antonio Álvarez Feria, an executive secretary, social security number 583-98-9879 and resident of Mayagüez, Puerto Rico, hereinafter referred to as the "Grantor";

As Party of the Second Part: Ángel Osvaldo Román López, of legal age, single, an engineer, social security number 584-13-7662 and resident of Guaynabo, Puerto Rico, hereinafter referred to as the "Grantee".

Attesting as to their authority to execute this Power of Attorney, the parties agree as following:

GRANT

One: Mr. Ángel Enrique Román Collazo died on April 19, 2000, hereinafter referred to as "Mr. Román".

Two: At the time of his death, Mr. Román was the sole shareholder of AERCO Broadcasting Corporation, a corporation created and organized pursuant to the laws of Puerto Rico, with its principal office located in San Juan, Puerto Rico, hereinafter referred to as the "Corporation".

Three: The parties are the sole heirs of Mr. Román, and upon his death became the only two shareholders of the Corporation; therefore,

each hold fifty percent (50%) of all the issued and outstanding common stocks of the Corporation.

Four: The Grantor appoints the Grantee as her sole attorney-in-fact as to all the rights, privileges and powers vested upon her as fifty percent (50%) shareholder of the Corporation, so that Grantor will exercise said power at his discretion and as if he was the owner of one hundred percent (100%) of all the Corporation's common stock issued and outstanding, including but not limited to exercise the right to vote on said stocks.

Five: The Grantor also appoints the Grantee as Chairman, President and Chief Executive Officer of the Corporation, including with it the power to control the operation and management of the Corporation, and carry on its business, without the need to be authorized by any other person or entity.

Six: The only power not vested upon Grantee, and which the Grantor keeps for herself, is the right to the payment of any dividend distribution as stockholder of record.

Seven: This Power of Attorney shall be incorporated into the corporate records of the Corporation for all legal purpose, both public and private.


Eight: The powers herein granted shall be in full force and effect until revoked or modified by a similar notarized document executed by
