Texas Christian University ("TCU"), licensee of Noncommercial Educational Station KTCU-FM (NCE), Ft. Worth, Texas, is a non-stock, non-profit, educational institution. TCU is filing this application to obtain Commission consent to new members of its Board of Directors.

The selection of TCU's new Board of Directors took place pursuant to its Articles of Incorporation and By-Laws. The resulting transfer of control occurred gradually, over time, through routine changes in board membership.

This application is intended to bring the station into compliance with the requirement to obtain FCC approval of the board after 50% of the members of the board of directors have changed. The FCC first approved the board of TCU in FCC File No. BPED-19780714AK, which was renewed on March 1, 1999, in BRED-19970327WA. The Board Members in 1978 and during each of the years after the last renewal application was filed are set forth in the chart on the below. The chart reflects the board members as they existed following the annual business meeting each year.

No consideration or thing of value is being given in exchange for the interests being transferred. All Board Members are U.S. citizens. Each Board Member has one vote. Except as set forth at the end of this exhibit, none have any interests in any mass media other than KTCU-FM.

Other Media Interests of Board Members

Deedie Potter Rose is a board member of North Texas Public Broadcasting, Inc., licensee of non-commercial educational Television Station KERA-TV(NCE) (Facility ID # 29324) and Radio Station KERA (FM-NCE) (Facility ID # 49323), both licensed to Dallas, Texas.

Mark L. Johnson holds a 0.71% limited partnership interest in LKCM Radio Investors II, Ltd., a limited partner of LKCM Radio Group, L.P. ("LKCM"), licensee of stations KRVA-FM, Campbell, TX (Facility ID # 54731); KFWR(FM), Mineral Wells, TX (Facility ID # 31062); and KRVF(FM), Kerens, TX (Facility ID # 41323). LKCM is also the permittee of new FM Channel 291 in Munds Park, AZ.

J. Luther King, Jr., is the 100% stockholder of LKCM Capital Group, Inc., the general partner of LKCM Radio Group, L.P., and holds a 30.29% interest in its limited partner. LKCM owns the stations listed in the preceding paragraph. Attached as Exhibit 12 to this application is a showing as to why Mr. King's board membership position in TCU should be exempt from attribution. He will recuse himself from any votes on the TCU board pertaining to KTCU-FM and not participate in any policy role or over-sight of KTCU-FM.
