We note that Tribes may have Section 106 cultural interests in ancestral homelands or other locations that are far removed from their current Seat of Government. Pursuant to the Commission's rules as set forth in the Nationwide Programmatic Agreement for Review of Effects on Historic Properties for Certain Undertakings Approved by the Federal Communications Commission (NPA), all Tribes and NHOs listed below must be afforded a reasonable opportunity to respond to this notification, consistent with the procedures set forth below, unless the proposed construction falls within an exclusion designated by the Tribe or NHO. (NPA, Section IV.F.4).

The information you provided was forwarded to the following Tribes and NHOs who have set their geographic preferences on TCNS. Beginning November 3, 2010 we are requiring a fax, mailing or shipping of materials to our tribal office regarding cell tower consultation. We will not handle any cell tower consultation electronically.

1. If your response from the FCC (through the TCNS or otherwise) lists the Peoria Tribe of Indians of

Oklahoma the Tribe is interested in consulting. As we have already defined our geographical areas of concern with the FCC, as is clearly noted on the TCNS web site, the FCC's response to you should list the Peoria Tribe only for those areas we have pre-defined.

When you receive the FCC response that lists the Peoria Tribe of Indians of Oklahoma for your area, you have been officially notified of our interest.

2. Please always use the TCNS number the FCC supplies you in any type of communication with us. We do not begin our research until we have the TCNS number. If you send us supplemental information at a later date, be sure to include the TCNS number on it, as well. Handwriting the TCNS number on your correspondence will be fine. Lack of a TCNS number on supplemental information will delay our response.

3. We do not wish to consult on co-locations that do not involve ground disturbance. We do wish to consult on co-locations that involve ground disturbance. If, after researching and spending some time on a project we then determine it is a co-location without ground disturbance, we will not refund the research fee. When we respond directly through the TCNS on tower sites, we cannot always determine that a tower will be a co-location with no additional ground disturbance. If you receive an e-mail from us through the TCNS on a tower that is a co-location without ground disturbance, you may simply fax us back and let us know, and we will close the file on that project. Please do not e-mail a response.

4. To initiate consultation with the Peoria Tribe please submit a brief project summary via U.S. mail or other carrier, together with a per-tower fee of \$100.00 to cover our research for the project location as well as general handling and processing of the documents you submit. Please note, this fee is NOT for determining our initial interest, as we have already done so by defining our geographic areas of interest through the TCNS, but for providing specialized information unique to the Peoria Tribe.

5. With the consultation initiation letter, please include the following:

a. Contact information, including phone and fax numbers, physical address, and e-mail address for the person (please specify by name) to whom information from the Peoria Tribe should be sent (this information should be included in the letter). If you do not include your fax number, it will delay our response. Please always give the phone number where we may reach you.

b. A copy of the review letter from the State Historic Preservation Office for the state

in which the tower is located. If (and only if) a separate Office of State Archaeology exists in the state that reviews and clears project separately from the SHPO (as in Oklahoma), then also send a letter from that office. The Peoria Tribe may request the SHPO (and Office of Archaeology, if applicable) letter before providing final comment on the project.

c. These portions of the archaeological report: research methods and findings for both the historic archives review and the field survey, plus a description of the project area's geomorphology and soils. The Peoria Tribe will request these parts of the archaeological report before commenting on the project. If you are not certain what to send from the archaeological report, please call and we will reach a mutual agreement about what sections we would like to see. Please do not send us the architectural survey information, unless it is embedded with the archaeological information. Only on rare occasions are we interested in standing architecture. We would appreciate 2 or 3 pictures of the project area.

d. A copy of the portion of the USGS quadrangle map, on which you have noted the project area location by a star or similar mark; please list the quadrangle name and date on the map (8.5x11 size is fine). Please do not send us multiple types of maps or engineering/construction drawings, or numerous photos.

e. Please fax or mail/ship us materials regarding cell tower consultation. We will not handle ANY cell tower consultation electronically. Fax(918-540-2538) or mail/ship information; you may also call us at 918-540-2535 with questions. We will not typically respond to requests received via e-mail.

6. PLEASE DO NOT SEND: the entire Form 620 and its attachments; various engineering or construction drawings; many different maps; resumes of archaeologists or historians; numerous photos of the location or of historical architecture (2-3 photos are appreciated). Please send only the items listed in item 5, above.

If a co-location project includes some new ground disturbance (such as from an expanded compound or access road, or construction of an ancillary structure), the Shawnee Tribe treats such a project the same as any other non co-location project.

As of 26 June 2006, all of the faxed responses of our final comments on a tower site will contain an original Shawnee Tribe signature. Each final comment fax is signed individually. Copies may be compared, for authentication, against the original in our files. If a final comment fax does not contain a signature, it is not valid. ALL FINAL COMMENTS FROM THE SHAWNEE TRIBE ARE WRITTEN; FINAL COMMENTS ARE NEVER PROVIDED VERBALLY. IF THE SHAWNEE TRIBE IS CREDITED WITH HAVING GIVEN A VERBAL RESPONSE, THAT RESPONSE IS NOT VALID.

If you receive notification through the TCNS listing the Shawnee Tribe, that is an indication that the Shawnee Tribe is interested in consulting on the tower for which that notification was received. Please consider that our official indication of interest to you. The Shawnee Tribe considers the Tower Construction Notification System's weekly e-mail to be the first notification that we receive that a tower will be constructed in an area of our concern. We do not view the TCNS notification as completion of 106 consultation obligations.

The Shawnee Tribe has developed streamlined consultation procedures for cell tower developers and their subcontractors. If you do not have a copy of the procedures - most recently updated on 14 January 2008 - please contact us, as you must follow these procedures to consult with us on cell tower projects. For all proposed projects, please E-MAIL a state map with the proposed site marked with an 'x' to David Grignon, Tribal Historic Preservation Officer, Menominee Indian Tribe of Wisconsin, at: dgrignon@mitw.org. It is very important that the map is sent to the Tribe ELECTRONICALLY. Additionally, the Menominee Indian Tribe of Wisconsin requires all applicants/tower builders to provide the Tribe with an archeological survey whenever there will be ground disturbing activity associated with the proposed project. Please E-MAIL the results of the archeological survey to: David Grignon, THPO, at: dgrignon@mitw.org. An archeological survey is not required if the proposed construction is a collocation on an existing tower, or located on a rooftop or water tower, or on ground that has been previously disturbed to two feet or below. For proposed sites in the State of Illinois, the Menominee Indian Tribe of Wisconsin is only interested in areas north of the Illinois River (including Chicago).
