

ADDITIONAL PARTIES TO THE APPLICATION

I. EDP Attributable Interest

The Application identifies the officers, directors, and members of the proposed assignee as parties who will hold direct attributable interests in WOLT(FM), Greer, South Carolina (FCC Facility ID No. 73241 upon consummation of the proposed transaction. In addition to those individuals and entities, Salem Communications Corporation (“**Salem**”) would hold an attributable interest in this radio station as a result of the application of the Commission’s “equity debt plus,” or EDP, attribution rule.

Salem Communications Corporation owns 100% of Salem Communications Holding Corporation, which (except as otherwise indicated) owns 100% of the licensee corporations listed in the “Other Authorizations” section below (“**Salem Licensee Corporations**”). Caron Broadcasting, Inc. is the licensee of same-market station WGTK-FM, Greenville, South Carolina (FCC Facility ID No. 73296). The proposed acquisition of WOLT(FM) by the proposed assignee would be financed through Salem such that Salem’s loan to the proposed buyers would exceed 33 percent of the total of the station’s equity and debt. Thus, Salem would hold an attributable interest in WOLT(FM) upon consummation of the proposed transaction.

IV. Multiple Ownership

Upon consummation of the proposed transaction, Salem will have an attributable interest in two FM stations in the market, which is permissible under Section 73.3555 of the Commission's rules.
