⁵ Included in the percentage of outstanding shares of Pandora held by Mr. Gotcher above is a 0.64% interest which is owned by the Peter and Marie-Helene Gotcher Family Trust, dated 11/20/08. Mr. Gotcher is a co-trustee of that trust.

⁶ Mr. Kavner owns no outstanding shares of Pandora in his own name, although Kavner Partners, a Delaware Multiple Series Limited Partnership (Series B) and various family trusts in the aggregate hold 0.4225% of the outstanding shares of Pandora. Mr. Kavner is a co-trustee of the family trusts.

⁷ In addition to the shares of outstanding stock of Pandora owned by Mr. Sze directly, 2.95% of the outstanding shares of Pandora on an aggregated basis are held by Greylock XII Limited Partnership, Greylock XII-A Limited Partnership and Greylock XII Principals LLC, collectively the Greylock Partners funds. Mr. Sze is a managing member of Greylock XII GP LLC, the sole general partner of Greylock XII Limited Partnership and Greylock XII-A Limited Partnership, and a member of Greylock XII Principals LLC, and therefore may be deemed to share voting power and investment control of the shares held by the Greylock Partners funds.

⁸ Crosslink Capital, Inc., is a beneficial owner of the Pandora shares held by Crosslink Crossover Fund IV, L.P., Crosslink Crossover Fund V, L.P., Crosslink Ventures IV GmbH & Co. KG, Crosslink Ventures IV, L.P., Crosslink Bayview IV, LLC, and Offshore Crosslink Ventures IV Unit Trust, which on an aggregated basis hold 18.26% of the outstanding shares of Pandora. Each of these funds individually holds less than a 5% voting interest in Pandora. The general partners of the six Crosslink entities holding Pandora stock are Crossover Fund IV Management, LLC; Crossover Fund V Management, LLC; and Crosslink Ventures IV Holdings, LLC. Mr. Feuille is a managing member of the general partner of the Crosslink Capital funds, and therefore may be deemed to share voting power and investment control over the shares held by various Crosslink Capital funds.

The officers, director, and shareholders of Crosslink Capital, Inc., who are attributable to Pandora are set forth below. Except for Michael Stark, no shareholder of Crosslink Capital holds more than a 5% indirect interest, using the multiplier, of Pandora. Mr. Feuille's interest in Crosslink Capital, Inc., is listed because he is a director of Pandora.
