

The Community of License for the station subject to this study is located in a county which BIA and Arbitron define as being part of an Arbitron Metro (Twin Falls, ID). Also, stations that are also to be commonly attributable with the above station have appeared “above the line” in an Arbitron Ratings as reported by BIA in the previous two years and are considered “home” to the market. Therefore, both the BIA/Arbitron Method and the Modified Contour Overlap Method shall be employed to demonstrate multiple ownership compliance with Section 73.3555.

KKMV(FM) has contemporaneously filed a minor modification application with commonly attributable station KZNO(FM). KKMV(FM) instantly proposes a one step upgrade from 291C0 to 291C and, consequently, the contour overlap for the station will change accordingly as its ERP is increased. The contemporaneously proposed KZNO(FM) application implements a change in operating channel from 275C1 to 276C1 pursuant to MB Docket 06-72. Therefore, no change in the contour of KZNO(FM) will occur and, therefore, examination of the KZNO(FM) licensed and proposed facility will yield the same results in regard to that station’s compliance with Section 73.3555.

The following map depicts two distinct radio overlap markets for the proposed facility. Market #1 on Map A includes 3 FM stations and 2 AM stations. Meanwhile, Market #2 on Map A includes only one AM and two FM stations. Therefore, both radio markets will be examined herein for contour overlap compliance with Section 73.3555.






