**SUPPLEMENT TO
RESPONSE TO
NOTICE OF APPARENT LIABILITY AND
REQUEST FOR CANCELLATION OR REDUCTION**

Aerco Broadcasting Corporation, licensee of television station WSJU-TV, San Juan, Puerto, by counsel, submits this supplement to the Response to the "Notice of Apparent Liability for Forfeiture" ("NAL") filed on March 7, 2014.

1. Paragraph 20 erroneously states that for 2010 and 2011 the average income for the AM and TV stations was \$1,196,880. That was the total income for the two years. The average income for the two years (both AM and TV) was \$598,440.
2. Paragraphs 22-23 of the Response stated that tax returns for 2012 and 2013 would be filed as a supplement.
3. There is attached hereto Aerco's 2012 tax return that shows a total income of \$882,219 with a net income of \$94,415. See Exhibit 4.
4. Aerco's tax return for 2013 has not yet been completed, but there is attached hereto an income statement for the year ending December 21, 2013 that shows a total income of \$693,258 with a net income (loss) of -\$113,628. See Exhibit 5.

5. The economy in Puerto Rico is still struggling to recover. The company is in a very precarious condition with stagnate revenues (typical for the local business economy) and marginal, often negative, income.


6. Under the circumstances, and considering the high level of local public affairs programming, a forfeiture is not warranted nor necessary to insure compliance with the station's public interest programming responsibilities.


