

# Agreement of Understanding

Between

KVIE, INC.

AND

YOUR CHRISTIAN COMPANION NETWORK, INC

This agreement is entered into as of the 14<sup>th</sup> day of April 2006 by and between KVIE, Inc. A California nonprofit public benefit corporation, (hereinafter referred to as KVIE), and KYCC et al, a non-commercial FM station (hereinafter referred to as KYCC).

KVIE and KYCC hereby enter into this agreement in accordance with the requirements specified by Federal Communications Commission Rules and Regulations Part 73.525.

KVIE is concerned with protecting our members and viewers from FM interference, both now and in the future. KVIE will agree to the proposed KYCC transmitter application under the following criteria:

1. Frequency is 90.1 MHz
2. ERP is 40.5 KW, Circular Polarization,
3. Antenna elevation shall not exceed 117 meters AMSL and shall be located at coordinates:  
Latitude: 37-57-30.1 Longitude: 121-16-54.7 .
4. KYCC specifically agrees to remedy properly verified cases by competent, trained technical personnel of off-the air KYCC interference to the KVIE signal within the affected KYCC area. Notch type coaxial cable filters equivalent to Microwave Filter Company Model 5KFM-90.1 will be obtained as needed to remedy specific cases in properly installed TV receiver systems. KYCC shall act in good faith to expeditiously assess and remedy bona fide problems of interference. If KYCC is unable to significantly reduce interference over a large coverage area KYCC will take other steps that may include reducing power or going off-air.
5. Beginning from the date of transmission from the new site, KYCC shall advertise weekly for 8 weeks, in a local newspaper stating: "Your Christian Companion Network is transmitting from a new transmitter in the Stockton, California area on 90.1 MHz and may cause interference to KVIE, Channel 6 in Sacramento. If you are experiencing interference from KYCC to KVIE, Channel 6 call Your Christian Companion Network / KYCC at 800-654-5254 during business hours."


6. Beginning from the date of transmission from the new site, KYCC shall make two announcements a day, one of them during "prime-time" hours for a period of 8 weeks as follows:

"KYCC Radio is transmitting from a new transmitter in the Stockton, CA area on 90.1 MHz and may cause interference to KVIE, Channel 6 in Sacramento. If you are experiencing interference from KYCC-FM to KVIE, Channel 6, call KYCC Radio at 800-654-5254 during business hours."

7. A copy of the daily logs containing announcements and copies of newspaper advertisements shall be mailed to KVIE, to the attention of the Manager of Engineering, monthly covering the time frame of the notice.
8. A log of interference calls with action taken shall be kept and a copy mailed to:

9. Your Christian Companion Network, Inc. has committed to being a "good neighbor" broadcaster in the past, correcting reception problems in a prompt and efficient manner. KVIE wishes to continue the cooperation with Your Christian Companion Network, Inc.


