SUMMARY

The following engineering statement has been prepared on behalf of **Lifeline Ministries, Inc.** (“**Lifeline**”), licensee of FM station WGTI Windsor, North Carolina, FCC ID 173. The facilities specified herein, and in FCC Form 301, Section III-B, are mutually exclusive with the license coordinates and thus believed to be in compliance with the minor modification rules established in *MM Docket No. 05-210* released November 29, 2006.

The application public interest merits are summarized as follows:

1. The community of Windsor, North Carolina has a population of 2,283 persons¹. AM station WBTE licensed to Windsor, North Carolina is not affected by this proposal and will continue to provide Windsor with local service.
2. The town of Duck, North Carolina was incorporated in 2002. No AM or FM stations are licensed to Duck, North Carolina.
3. The proposed Channel 249C2 allotment site at Duck, North Carolina complies with the Commission’s allocation spacing rules for a fully spaced Class C2 facility.
4. The proposed WGTI allotment at Duck, North Carolina would bring a first local aural service to that community.

¹ All population data from 2000 U.S. Census unless otherwise stated.

URBANIZED AREA

Based on U. S. Census data, no urban areas are associated with the WGTI authorized or proposed facilities. Neither the licensed facility 70 dBu nor the proposed 70 dBu covers a census designated urban area.

POPULATION DATA – ALLOTMENT

The licensed and proposed 70 dBu and 60 dBu population data is listed below. The population data is based on 2000 Census data with the contour locations based on a constant radius appropriate for the class of FM facility.

POPULATION DATA – LICENSED & PROPOSED FACILITIES.

The licensed and proposed 70 dBu and 60 dBu population data is listed below. The population data is based on 2000 Census data with the contour locations based on 72 evenly spaced radials computed using the Radio Soft 3 second (NGDC Based) high accuracy 3 second terrain database for FM stations. Distances to FM contours were determined using the methodology found in 73.313.

PROTECTED AURAL SERVICE

Windsor, North Carolina, the current community of license, receives protected aural service from 10 FM radio stations. Duck, North Carolina, the proposed community of license, receives protected aural service from 11 FM radio stations. This analysis is based on FM services to 100% of the community of license. No AM station analysis was undertaken as the communities receive a number of FM services. In no case is either community underserved and there are no white or gray areas.

GAIN AND LOSS AREAS

The proposed reallocation proposes a transmitter site change which results in no common overlap of the proposed and licensed allotment 60 dBu contours. The gain area will encompass 8,484 square kilometers and a population of 469,528 persons. The loss area will encompass 1,660 square kilometers and a population of 19,664 persons. The net gain in service is to 449,864 persons in an area of 6,824 square kilometers.


MULTIPLE OWNERSHIP

Lifeline owns WIAM, FCC ID 37450, which is more than 100 km distant from the proposed facility and not involved in common overlap.

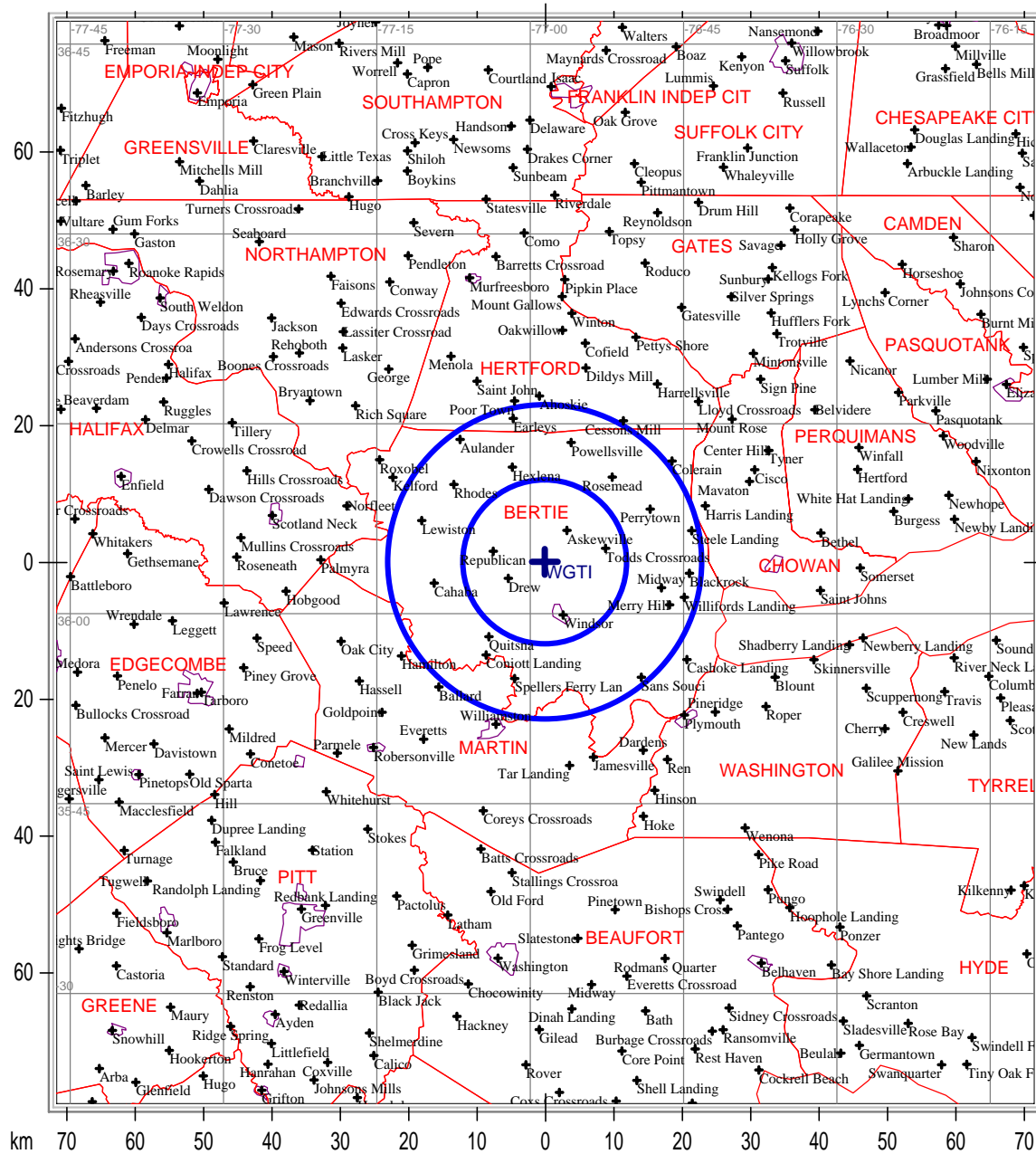

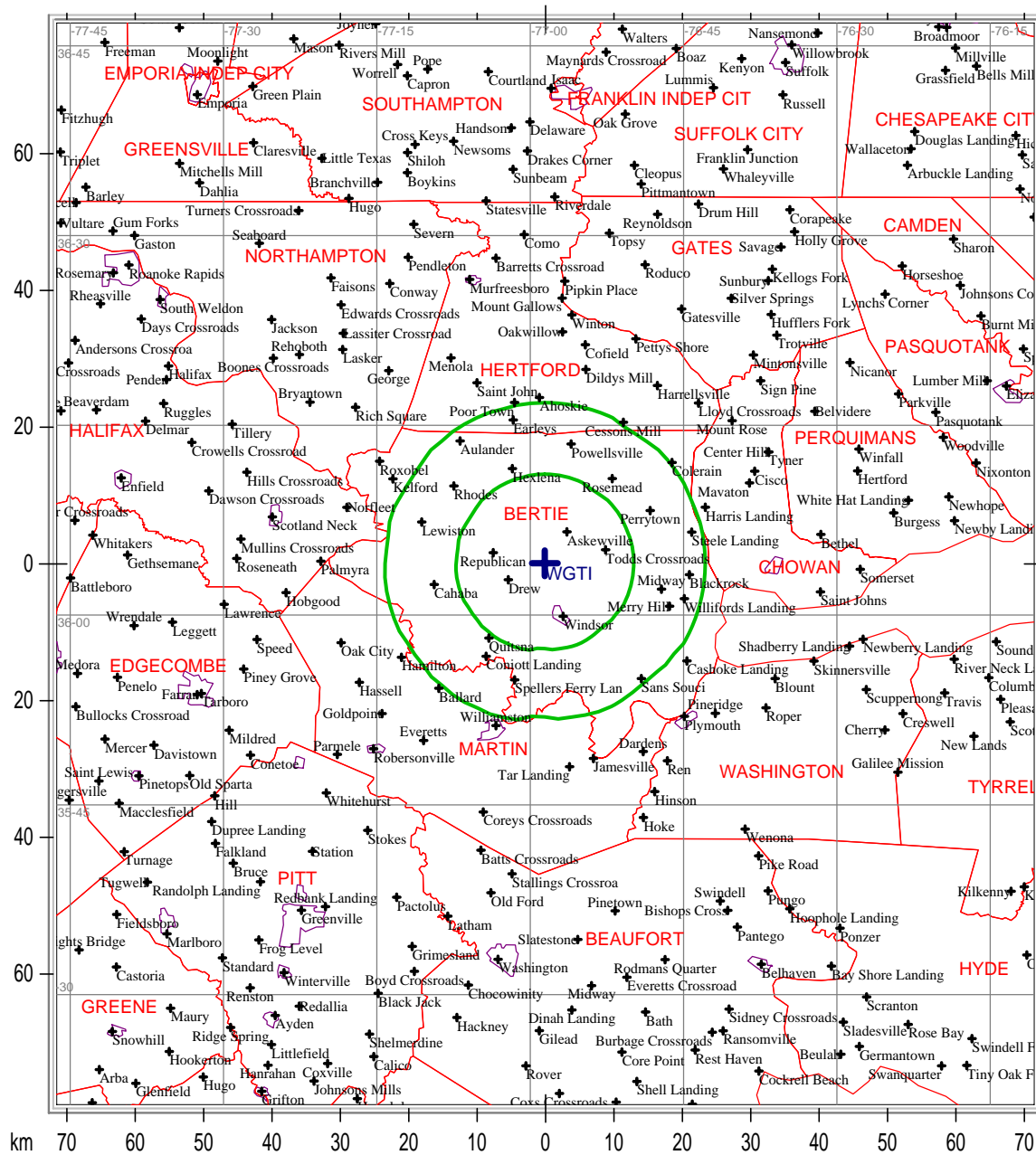

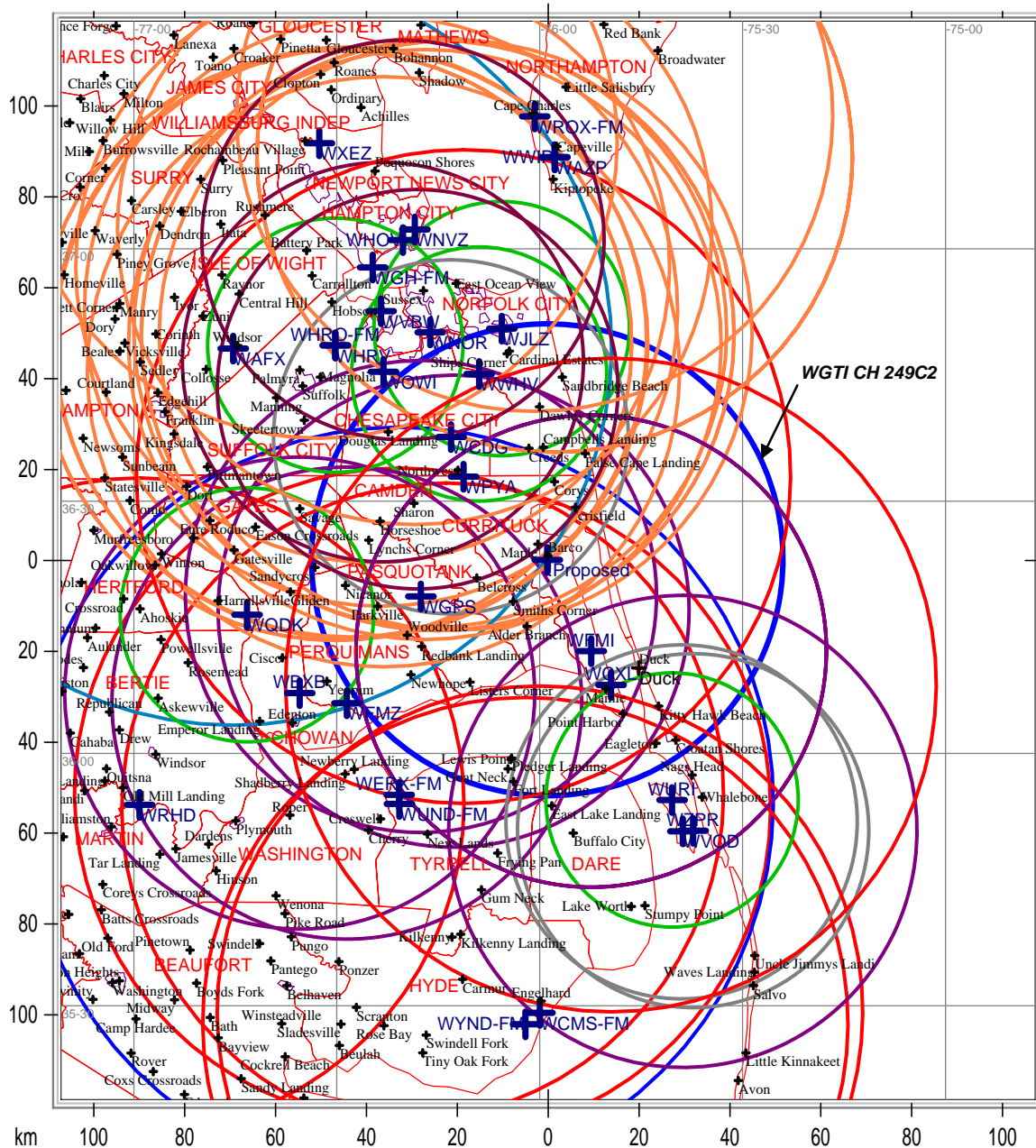

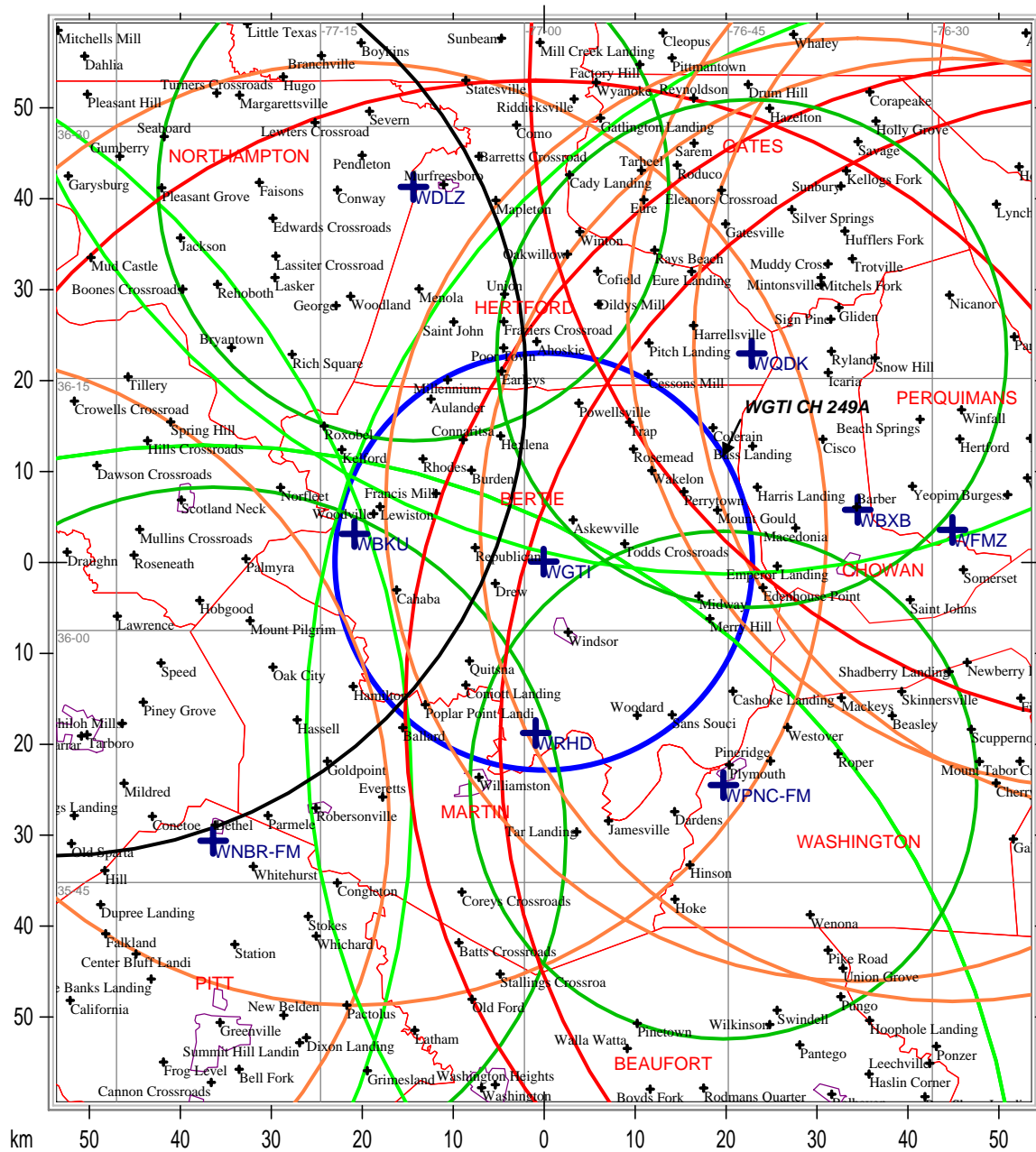
