TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of RM Broadcasting, LLC (“RM”), proposed assignee of KMRJ, Channel 258A, Rancho Mirage, California. RM is also the licensee of KPLM, Channel 291B, Palm Springs, California and KJJZ, Channel 272A, Indio, California. RM has a Joint Sales Agreement (JSA) with the licensee of KAJR, Channel 240A, Indian Wells, California. Each of these stations is licensed to a community in a metro county in the Palm Springs, California Arbitron Market. Therefore, this review will verify compliance with the Commission’s multiple ownership rules in a rated market.

PALM SPRINGS, CALIFORNIA
ARBITRON/BIA MARKET REVIEW

2. As shown on Exhibit #1, there are twenty-six AM and FM (commercial and non-commercial) stations listed in the Palm Springs, California Arbitron Market (Market #131). RM would be in control of four FM stations in the market. The number of stations indicated falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Therefore, RM’s ownership of KMRJ, in conjunction with its interest in KJJZ, KPLM and KAJR in the Palm Springs, California Arbitron Market, is in compliance with the rules. Based on the foregoing, the assignment of KMRJ to RM is in compliance with §73.3555 of the rules.

3. The foregoing technical statement was prepared on behalf of RM Broadcasting, LLC by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.3. BIA database. Technical data related to AM and FM facilities was extracted from the Commission's CDBS database. We assume no liability for errors or omissions in that database which may be adverse to the information contained herein.


