Dear Counsel:

This is in reference to the request filed June 18, 2010, on behalf of Entercom Boston License, LLC ("Entercom"). Entercom requests special temporary authority ("STA") to operate Station WEEI during daytime hours with parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits.¹ Entercom states that the station currently is operating under STA relative to its nighttime pattern, and that construction work on a nearby cellular tower now has caused the daytime parameters to vary outside licensed limits.

Accordingly, the request for STA IS HEREBY GRANTED. Station WEEI may operate during daytime hours with parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or cease operation if complaints of interference are received. Entercom must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **October 14, 2010**.²

STA Advisory: Section 309(f) of the Communications Act of 1934, as amended, authorizes the Commission to grant STA in cases of "extraordinary circumstances requiring temporary authorizations in the public interest and when delay in the institution of the temporary operations would seriously prejudice the public interest." However, Section 309(f) is not a means by which a licensee/permittee may circumvent established processing procedures which require the filing of an application, nor is it a means by which a broadcaster may enhance his facility or make operation more convenient for the broadcaster. Stations operating with less than licensed facilities under temporary authorities can be viewed as receiving the benefit of a larger protection area than that in which they are currently providing service.

¹ WEEI is licensed for operation on 850 kHz with 50 kilowatts, unlimited hours, employing different directional antenna patterns daytime and nighttime (DA-2-U).

² This is the same as the expiration date of the nighttime STA. In the event that extension of both is required, only a single request need be filed.

Accordingly, Special Temporary Authorities by nature are to be temporary and are not intended for extended use. Licensees of stations operating under temporary authorities are reminded that timely restoration of permanent facilities is the responsibility of the licensee and should be undertaken expeditiously. Any request for extension of special temporary authorities carries an increased burden with each subsequent request.

Therefore, requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.
