¹ The parties have agreed that: (1) MGTF Holdco, LLC has the right to appoint three persons to serve on the Board of Directors of MGTF Radio Company, LLC (“MGTF”); and (2) Business Development Corporation of America (“BDCA”) through 54th Street Equity Holdings, Inc., the minority member of MGTF, has the right to appoint two persons to serve on the Board of Directors of MGTF. BDCA has not yet determined the identities of the two persons it may appoint to serve as directors on the Board of MGTF. Prior to the appointment of those directors, BDCA will ensure that each such person is qualified under the Communications Act of 1934, as amended, and the Commission’s rules.
