

### **Description of Transaction, Changes in Interests, and Use of Form 316**

In a series of 23 concurrently filed applications, SummitMedia LLC seeks consent to the assignment of all licenses it currently holds to wholly-owned licensee subsidiaries, as listed below. SummitMedia LLC will be the sole member of each of the individual licensee companies, each of which will be a single-member limited liability company. No substantial change to the ownership and control of SummitMedia, LLC itself is proposed. The ownership and control of SummitMedia LLC is set forth on the following pages. A graphical representation of the ownership structure of each assignee is also provided.

Because the proposed transaction involves assignment from a licensee to its wholly-owned subsidiaries, and therefore does not involve any substantial change in the ultimate ownership and control of the licenses, use of Form 316 is appropriate for this transaction.
