

## EXHIBIT 6

The Tillicum Foundation (“Tillicum”), licensee of noncommercial station KMUN, Astoria, Oregon, requested and obtained a waiver of the main studio rule as a condition of its construction permit for a new noncommercial educational (“NCE”) FM station to serve Tillamook, Oregon (BPED-19990706MA). Oregon Public Broadcasting, licensee of NCE station KOPB, Portland, Oregon, also obtained a construction permit for an NCE station to serve Tillamook, Oregon (BPED-19990503MA) and a waiver of the main studio rule. Tillicum and OPB then swapped construction permits. The Tillicum permit still accurately indicates that it has been granted a waiver of the main studio rules, but inaccurately indicates that the Tillamook station will serve as a satellite of KOPB, rather than KMUN. Subject to the provisions of the Communications Act of 1934, as amended, subsequent acts and treaties, and all regulations heretofore or hereafter made by this Commission, and further subject to the conditions set forth in this permit, the permittee is hereby authorized to construct the radio transmitting apparatus herein described. Installation and adjustment of equipment not specifically set forth herein shall be in accordance with representations contained in the permittee's application for construction permit except for such modifications as are presently permitted, without application, by the Commission's Rules.

Commission rules which became effective on February 16, 1999, have a bearing on this construction permit. See Report & Order, Streamlining of Mass Media Applications, MM Docket No. 98-43, 13 FCC RCD 23056, Para. 77-90 (November 25, 1998); 63 Fed. Reg. 70039 (December 18, 1998). Pursuant to these rules, this construction permit will be subject to automatic forfeiture unless construction is complete and an application for license to cover is filed prior to expiration. See Section 73.3598.

Equipment and program tests shall be conducted only pursuant to Sections 73.1610 and 73.1620 of the Commission's Rules.

- 1 Permittee has specified use of a two section antenna to demonstrate compliance with the FCC radiofrequency electromagnetic field exposure guidelines. If any other type or size of antenna is to be used with the facilities authorized herein, THE AUTOMATIC PROGRAM TEST PROVISIONS OF 47 C.F.R. SECTION 73.1620 WILL NOT APPLY. In this case, a FORMAL REQUEST FOR PROGRAM TEST AUTHORITY must be filed in conjunction with FCC Form 302-FM, application for license, BEFORE program tests will be authorized. This request should be made at least 10 days prior to the date on which program tests are desired to commence. The request must include a revised RF field showing to demonstrate continued compliance with the FCC guidelines.

Documentation demonstrating compliance with the FCC radiofrequency field exposure guidelines may be submitted in advance of the filing of FCC Form 302-FM. The Commission's staff will review it for compliance and respond by letter stating whether automatic PTA has been reinstated.

- 2 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
- 3 Waiver of 47 C.F.R. Section 73.1125 is granted to allow operation of the facility authorized by this construction permit as a satellite operation of the following station:

KOPB-FM, Portland, OR, Facility ID No. 50607

Dear Ms. Dortch:

The purpose of this letter is to ask that you correct condition #3 of the construction permit for noncommercial educational FM station KTCB, Tillamook, Oregon to indicate that KTCB will operate as a satellite of KMUN, Astoria, Oregon.

The Tillicum Foundation ("Tillicum") is the licensee of noncommercial educational stations KMUN(FM), Fac. ID 67107, Astoria, Oregon and KTCB(FM), Fac. ID 98286, Tillamook, Oregon. KTCB was granted a construction permit on July 8, 2002 to operate as a satellite of KOPB-FM, Fac. ID 50607, Portland, Oregon, licensed to Oregon Public Broadcasting. Pursuant to Commission authority, the construction permit for KTCB was assigned from Oregon Public Broadcasting to Tillicum on January 23, 2003. KTCB will operate as a satellite of KMUN(FM), licensed to Tillicum, rather than as a satellite of KOPB-FM, licensed to Oregon Public Broadcasting. Please correct the construction permit and FCC records accordingly.
