
This is in reference to the request filed February 20, 2008, on behalf of Great Lakes Community Broadcasting, Inc. ("GLC"), licensee of W221BQ, Petoskey, Michigan. GLC requests special temporary authority ("STA") to rebroadcast the programming of AM Station WMKT(AM), licensed to MacDonald Garber Broadcasting, Inc. in Charlevoix, Michigan, on FM Translator W221BQ. In support of the request, GLC states that WMKT(AM) is unable to provide an interference-free signal to the area as a result of interference from adjacent-channel stations.

Having given the proposal thorough consideration, we find that the Public Interest would be served by grant of GLC's request.

Accordingly, the request for STA IS HEREBY GRANTED. Station WMKT(AM) may rebroadcast its programming on FM Translator W221BQ. GLC must take whatever steps are necessary to prevent exposure of workers and/or the public to radio frequency fields in excess of the Commission's exposure limits. *See* 47 CFR Sections 1.1307(b), 1.1310.

This authority expires on **December 25, 2008**.

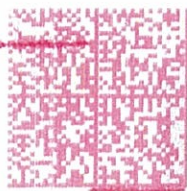
