

## **PARTIES TO THE APPLICATION**

The proposed assignee of WLNY-TV, Facility ID No. 73206, Riverhead, New York (the "Station"), is WLNYEAT, LLC ("WLNYEAT"). The members of WLNYEAT are TVPEAT, Inc. ("TVPEAT") and CBS LITV LLC ("CBS LLC").

### **Ownership Information for TVPEAT**

TVPEAT holds 100% of the equity of WLNYEAT and is the Managing Member. TVPEAT is a wholly owned subsidiary of TVPX 1031 Exchange Co. Information about the ownership, officers, and directors of TVPEAT and TVPX 1031 Exchange Co. is set forth in charts at the end of this exhibit.

### **Ownership Information for CBS LLC**

CBS LLC is the FCC Managing Member of WLNYEAT. Although CBS LLC is for tax purposes required to be a non-equity member, the governing documents for WLNYEAT make clear that CBS will have exclusive control of the Station.

The sole member of CBS LLC is CBS Radio Stations Inc. ("CBS Radio Stations"). CBS Radio Stations is a wholly owned subsidiary of CBS Radio Media Corporation ("CBS Media"). CBS Media is a wholly owned subsidiary of CBS Radio Inc. ("CBS Radio"). CBS Radio is a wholly owned subsidiary of CBS Broadcasting Inc., which in turn is a wholly owned subsidiary of Westinghouse CBS Holding Company, Inc. ("Westinghouse"). Westinghouse is a wholly owned subsidiary of CBS Corporation. CBS Corporation is a publicly-traded company that is controlled by a single majority voting shareholder, National Amusements, Inc. ("NAI"), through its direct and indirect ownership of a 79.06% voting interest.

NAI is controlled by Sumner M. Redstone through the Sumner M. Redstone National Amusements Trust u/d/t dated 6/28/02 ("Sumner M. Redstone Trust"), which owns approximately 80% of the voting interest of NAI. Sumner M. Redstone, David Andelman, Phyllis Redstone, George Abrams, Norman I. Jacobs, Leonard L. Lewin and Philippe Dauman are the trustees of the Sumner M. Redstone Trust. Voting shares of the Sumner M. Redstone Trust are voted solely by Sumner M. Redstone until such time as his incapacity or death.

Because CBS Corporation is controlled by a single majority voting shareholder, NAI, no minority ownership interests in CBS Corporation are attributable. On December 14, 2001, the Commission suspended the elimination of the single majority shareholder exemption for purposes of the broadcast and cable/MDS attribution rules pending the resolution of the Commission's Further Notice of Proposed Rulemaking in CS Docket Nos. 98-82, 96-85, and MM Docket Nos. 92-264, 94-150, 92-51 and 87-154. *Review of the Commission's Regulations*

*Governing Attribution of Broadcast and Cable/MDS Interests*, FCC 01-353 (released December 14, 2001).

In addition, no person or entity holds more than 33% of the total assets (debt plus equity) of CBS Corporation. Therefore, no person or entity has an attributable interest in CBS Corporation under the Equity/Debt Plus (“EDP”) Rule. *See* 47 C.F.R. § 73.3555 Note 2(i).

Set forth below, in the Section III, Item 4 format, is more detailed information concerning the ownership, officers, and directors of WLNYEAT and all persons holding attributable interests in WLNYEAT.
