Dear Counsel:

This is in reference to the request filed June 28, 2006, on behalf of Fleur de Lis Broadcasting, Inc. ("FLB"). FLB requests extension of the special temporary authority ("STA") granted on October 4, 2005, and modified on January 9, 2006, to operate Station WTIK-FM with emergency antenna facilities pursuant to Section 73.1680.¹ In support of the request, FLB provides a report of its progress toward restoring licensed operation.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made progress toward restoration of licensed operation, but additional time is required for completing the work. Thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WTIK-FM may continue to operate with the following facilities:

Geographic coordinates: 29° 55' 11" N, 90° 01' 29" W (NAD 1927)
Channel 232 (94.3 MHz)

¹ WTIK-FM is licensed for operation on Channel 232C1 (94.3 MHz) with effective radiated power of 100 kilowatts (H&V) and antenna height above average terrain of 299 meters.

FLB must notify the Commission when licensed operation is restored. FLB must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **November 22, 2007**.
