**City of License Change Review**

This application seeks to change the community of license of KBBF, Channel 206B, from Santa Rosa, California to Calistoga, California, using the recently adopted city of license change procedures, as outlined in *Revision of Procedures, 21 FCC, Rcd 14212 (2006)*. BBF herein reviews the proposed change and demonstrates it is in compliance with the Commission's rules/procedures for a change. This application is being submitted contingently with an application by the licensee of station KSXY to change its community of license from Calistoga, California to Forestville, California. KBBF will provide replacement service to Calistoga.

As indicated on Exhibit A1, Channel 206B, at the proposed/licensed site, complies with the interference rules to all other non-commercial stations operating on co- or adjacent channels.<sup>1</sup> The proposed change of community to Calistoga is mutually exclusive with the licensed KBBF facility at Santa Rosa, California. As such, KBBF's proposed change of community of license to Calistoga will insure that community retains local service.<sup>2</sup> Since there are numerous other

- 1) No changes are proposed to the licensed facilities of KBBF except for the change of community of license. KBBF delivers interference to and received interference from KHAP, Channel 206B1, Chico, California. This interference was caused by the application to relocate KHAP (BMPED-19860807MD) with a license to cover the permit (BLED-19880915KB). Since KBBF was in existence years prior to the KHAP relocation application and is not proposing any technical changes in this instant application, the interference between the stations is considered grandfathered and is addressed herein.
  - 2) Presently KSXY is on the only service licensed to Calistoga, California

services licensed to Santa Rosa<sup>3</sup>, the change of community of license for KBBF from Santa Rosa to Calistoga will not leave Santa Rosa without service.

Exhibit C1 is a coverage map of KBBF, showing the proposed/existing facility provides a 70 dBu contour over all of the proposed community of license of Calistoga. KBBF provides a 60 dBu contour to 536,584 persons in 5,951.7 square kilometers and a 70 dBu contour to 192,358 persons in 1,871.3 square kilometers. KBBF is proposing to change its community of license from Santa Rosa to Calistoga at its existing site with no changes to the existing facilities of KBBF. As such, there are no gain or loss issues to be reviewed. Attached as Exhibit C2 are the stations providing protected service to Calistoga, California. Exhibit C3 is a tabulation of the stations providing service to Calistoga, California.<sup>4</sup> Exhibit C4 is a map showing the number of stations providing predicted service to Santa Rosa, California. Exhibit C5 is a tabulation of the stations depicted on Exhibit C4.<sup>5</sup> Based on the foregoing, the change of community of license for KBBF complies with the Commission's rules and regulations.

- 3) KBBF, Channel 206B; KRCB-FM, Channel 216A; KZST, Channel 261A; KXFX, Channel 269B1; KSRO AM, 1350 kHz; and KRRS AM, 1460 kHz, are all licensed to Santa Rosa.
  - 4) The AM service contours depicted are the daytime 2.0 mV/m, since the population of Calistoga is more than 2,500.
  - 5) The AM service contours depicted are the 2.0 mV/m, since the population of Santa Rosa is more than 2,500.



