

**COMPLIANCE WITH 47 C.F.R. § 73.3555(c): THE RADIO-TELEVISION  
CROSS OWNERSHIP RULE**

Millennium Atlantic City II License Holdco, LLC (“Millennium Atlantic City II”), which is indirectly wholly-owned and controlled by Millennium Radio Group, LLC (“Millennium Radio”), seeks prior FCC consent to acquire broadcast station WOJZ(FM), Egg Harbor City, New Jersey from Nassau Broadcasting II, L.L.C. Alta/Millennium Corp., a member of Millennium Radio, has an attributable interest in WWSI(TV), Atlantic City, New Jersey. The Grade A contour of WWSI(TV) wholly encompasses Egg Harbor City. Accordingly, this exhibit is being submitted to demonstrate that common ownership of these two broadcast stations complies with the Commission's radio-television cross-ownership rule, 73 C.F.R. §73.3555(c).

Pursuant to the radio-television cross-ownership rule, a party may own up to two television stations and up to four radio stations in any market where at least 10 independently owned media voices remain after the combination is effected. The proposed common ownership of WWSI(TV) and WOJZ(FM) is in accord with this rule. WWSI(TV) is located in the Philadelphia, Pennsylvania DMA and the Atlantic City – Cape May, New Jersey radio metro market, while WOJZ(FM) is located in the Philadelphia DMA and the Philadelphia radio metro market. Because the television station and radio stations are located in different radio metro markets, the voice requirement must be met in each radio metro market. *See* 47 C.F.R. §73.5555(c)(3)(ii)(B). However, since the Atlantic City – Cape May market is the smaller of the two radio markets<sup>1</sup>, the instant analysis considers only the Atlantic City-Cape May metro market. There are at least 26 independent voices in the market (19 independent television voices, 5 additional independent radio voices, and 2 newspapers). *See* Attachments 1 hereto. Accordingly, as there are more than 10 independent voices in the market, common ownership of one television station and one radio station in the market is permissible.
