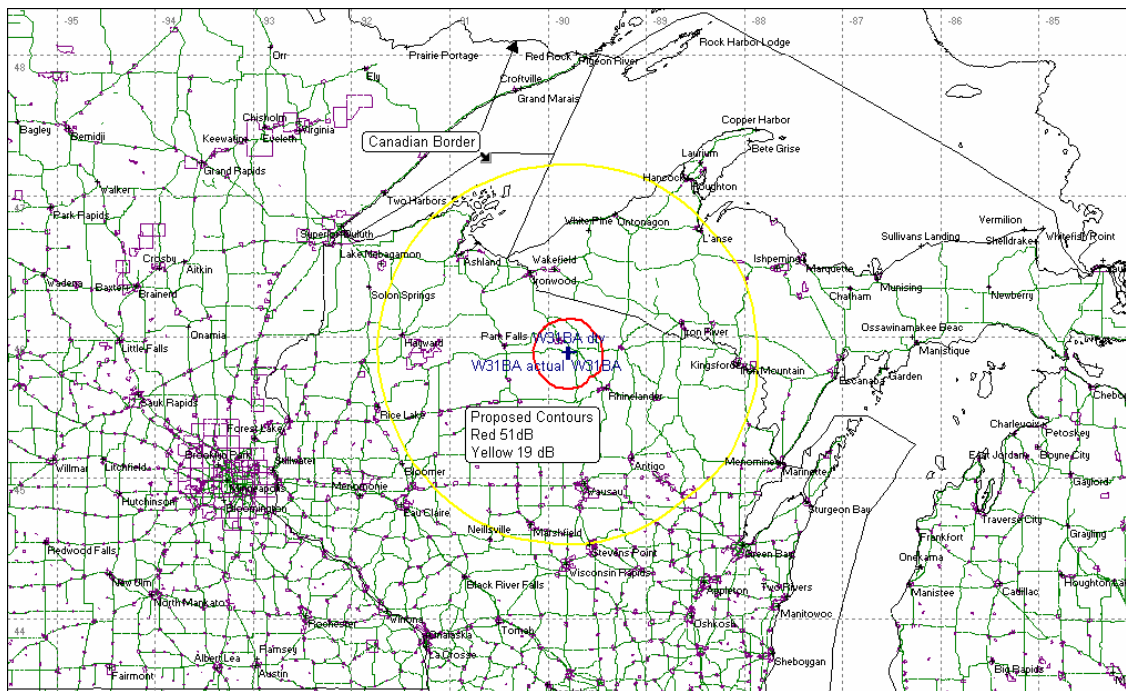
In evaluating the proposed Digital Flash Cut for W31BA, FID 57592, an outgoing interference study was executed on the proposed parameters on channel 39(T) with an ERP of 2.3 KW. The stations listed in the table below showed possible interference. When these stations were evaluated for outgoing interference using the OET-69 Longley Rice methodology with a cell size of 1km and a 0.1km radial spacing, there was zero percent interference present found when rounded to the nearest percent.

Three Angels Broadcasting Network also requests a waiver of international coordination with Canada since the proposed 19 dBu (50,10) does not cross into Canadian territory. Please see the coverage map below.
