

MULTIPLE OWNERSHIP EXHIBIT

This application is one of a series of applications pursuant to which consent is sought to the assignment of license of television stations licensed to various entities controlled by the Freedom Communications Broadcast Trust to entities affiliated with Sinclair Broadcast Group, Inc. (“SBGI”). Specifically, this application seeks consent to the assignment of license of commercial broadcast television station WPEC(TV), Facility ID 52527 (“WPEC”), West Palm Beach, Florida, from Freedom Broadcasting of Florida Licensee, L.L.C. to WPEC Licensee, LLC, a subsidiary of SBGI.

The FCC’s television duopoly rule permits a single entity to directly or indirectly own, operate, or control two television stations in the same DMA under two circumstances:

- (1) Where the Grade B contours of the stations do not overlap, or
- (2) (i) at the time of the filing of the application, at least one of the stations is not among the top four ranked stations in the market, based on the most recent all-day (9:00 a.m.– midnight) audience share as measured by Nielsen Media Research or a comparable ratings service, and (ii) at least 8 independently owned and operating full-power commercial and noncommercial television stations will remain in the DMA following the merger of the two stations.¹

On September 14, 2011, an application was filed seeking Commission consent for the assignment of the license of television station WTVX(TV), Fort Pierce, Florida, from an entity associated with Four Points Media Group LLC to WTVX Licensee, LLC, a subsidiary of SBGI. *See* FCC File No BALCDT- 20110914ADP. That application remains pending at the FCC.

Upon consummation of the transaction proposed herein and that of the WTVX(TV) transaction, SBGI will have attributable ownership interests in stations WTVX(TV) and WPEC(TV), both located in the West Palm Beach-Fort Pierce, Florida Designated Market Area (the “DMA”). As shown in Attachment 1 hereto, some ten independent full power television stations will remain in the DMA after the consummation of the transactions. In addition, based on the most recent all-day audience share data for the 2010-2011 TV Season published by Nielsen Media Research, WPEC(TV) is not ranked among the top four stations in the DMA. Consequently, SBGI’s ownership of attributable interests in both stations complies with the television duopoly rule.
