Application for Transfer of Control
Daytona State College, Inc.

This application is submitted to request approval of the transfer of control of Daytona State College, Inc. (“DSC”), licensee of television station WDSC-TV, New Smyrna Beach, Florida. DSC is a non-profit educational institution which is an agency of the State of Florida. The College is governed by a Board of Trustees appointed by the Governor of Florida. The Board currently has nine members, with each holding an equal 11.1% vote. Members of the Board are from time to time replaced by new appointments. The transfer of control for which approval is sought occurred as a result of gradual changes in the composition of the Board of Trustees since the last time the Commission approved the make-up of the council in 2012 (*See* BTCEDT-20121017AAH, granted November 1, 2012). The members of the Board in each year since the grant of that application are identified below to demonstrate the gradual nature of the changes to the Board of Trustees. The second chart below also identifies the current members of the Board of Trustees by name and address, including any positional interests held. The Commission has long approved such gradual transfers of control of non-commercial, governmental licensees through the use of Form 316.
