Other Authorizations

Television Station Group Holdings, LLC wholly owns Television Station Group, LLC, which, in turn, wholly owns Television Station Group License Subsidiary, LLC, the licensee of full-service television stations WTAJ-TV, Johnstown/Altoona, Pennsylvania (Facility ID No. 23341), and WLYH-TV, Lancaster, Pennsylvania (Facility ID No. 23338). The Commission has granted its consent for the *pro forma* assignment of the license (FCC File No. BALCT-20010120ADG) for WTAJ-TV and WLYH-TV from Television Station Group License Subsidiary, LLC to Television Station Group Pennsylvania License Subsidiary, LLC, but that *pro forma* assignment has not yet been consummated.
