## ENGINEERING STATEMENT:

KIFM Sacramento, CA Facility ID 67848  
Construction Permit BP-20210903AAF

Construction has commenced for the facilities authorized in the BP-20210903AAF permit. Operation of the nighttime facilities authorized in the permit with substantially adjusted parameters per the provisions of 47CFR73.1615(b)(6) has now commenced. Because of changes to the antenna monitoring system, special temporary authority for operation of the daytime pattern with parameters at variance is also necessary, and is respectfully requested. There will be no changes in the daytime pattern operation itself, or in monitor point indications, but the parameters as indicated on the antenna monitor have changed, and modification of those parameters will be requested as a part of the license application for the BP-20210903AAF facilities.
