

MUTUAL CONSENT AGREEMENT

This Mutual Consent Agreement (the "Agreement") is made as of March 1, 2007 by and between Southern Nevada Educational Broadcasters ("Southern"), and EDUCATIONAL MEDIA FOUNDATION ("EMF").

WHEREAS, EMF and Southern desire to jointly consent to mutual contingent minor changes to the facilities of their stations, KAIZ(FM), Mesquite, Nevada and KVKL(FM), Las Vegas, Nevada, respectively.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which is acknowledged by the parties, and upon the mutual promises and covenants made herein, the parties hereto agree as follows:

1. EMF hereby agrees to request a minor modification of its KAIZ(FM) licensed facilities to downgrade the station facilities to Class A at 400 watts effective radiated power ("ERP") contingent upon Southern's agreement to upgrade KVKL's facilities to Class C1 at 44.8 kw ERP.
2. Southern hereby agrees to request a minor modification of its KVKL(FM) licensed facilities to upgrade the station's facilities to Class C1 at 44.8kw ERP contingent upon EMF's agreement to downgrade KAIZ's facilities to Class A at 400 watts ERP.
3. The parties hereby agree to coordinate and concurrently file with the FCC an application to modify the facilities of their respective facilities. EMF and Southern agree that other than the exchange of promises, no other consideration, including monetary consideration, will be due to or from either party.
4. Each party agrees that no change in facilities shall be effectuated by either party unless and until the FCC has granted both parties' applications.
