In turn, Sweetwater is owned by Uhlmann/Latshaw Broadcasting, LLC ("Uhlmann/Latshaw") (51% of the outstanding voting shares) and Bozeman Trail Communications Company ("Bozeman Trail") (49% of the outstanding voting shares).

Bozeman Trail is the wholly owned subsidiary of Sunbelt Communications Company. The attributable interest of each of the above parties is set forth below.
