
Dear Ms. Dortch:

On June 6, 2006, the Gary M. Cocola Family Trust, Gary M. Cocola, Trustee (the "Trust"), submitted the above-referenced application on FCC Form 175 for a digital companion channel for KZKC-LP (formerly KPMC-LP) (the "Application"). The Trust subsequently assigned the license for KZKC-LP to the McGraw-Hill Broadcasting Companies. On October 17, 2006, the Commission determined that the Application was mutually exclusive with other applications assigned to MX Group MX057.

The Trust has elected to withdraw its proposal for a digital companion channel for KZKC-LP (formerly KPMC-LP). Accordingly, the Trust today deleted the KZKC-LP proposal from its FCC Form 175, and, out of an abundance of caution, the Trust hereby submits the enclosed letter withdrawing the KZKC-LP digital companion channel application.


Dear Ms. Dortch:
