ARTICLES OF INCORPORATION

OF

CALVARY COMMUNITY CHURCH OF CONEJO VALLEY, INC.

I

The name of this corporation shall be CALVARY COMMUNITY
CHURCH OF CONEJO VALLEY INC.

II

The purposes for which this corporation is formed are:

(a) The specific and primary purpose is
to maintain and operate a church for religious purposes and
to advance the Kingdom of Jesus Christ through public worship
of God, the preaching of the Gospel and the living of consistent
Christian lives, personal evangelism, missionary endeavor and
Christian education.

(b) The general purposes and powers are to
have and exercise all rights and powers conferred on non-profit
corporations under applicable laws of the State of California,
including but not limited to the powers of contract, mortgage,
borrow money, buy or sell personal and real property or to en-
gage in any activity that will promote the specific and primary
purpose of the corporation.

(c) Notwithstanding any of the above state-
ments of purposes and powers, this corporation shall not, except
to an insubstantial degree, engage in any activities or exercise
any powers that are not in furtherance of the primary purpose of
this corporation.

III

This corporation is organized pursuant to the general non-profit corporation laws of the State of California and does not contemplate pecuniary gain or profit to the members thereof and it is organized for non-profit purposes.

IV

The county in this State where the principal office for the transaction of business of this corporation is located in Ventura County.

V

VI

The authorized number and qualification of members of the corporation and the different classes of membership, if any, the property voting or other rights and privileges of members, and their liability to dues, assessments and the method of collection thereof, shall be as set forth in the By-Laws.

VII

The property of this corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of this organization shall ever inure to the benefit of any director, officer or member thereof, or to the benefit of any private persons. Upon dissolution or winding up of the corporation, its assets remaining after payment or provision of payment of all debts and liabilities of this corporation, shall be distributed to a non-profit fund, foundation or corporation which is organized and operated exclusively for religious purposes and which has established its tax exempt status under §501(c)(3) of the Internal Revenue Code.

VIII

No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements on behalf of any candidate).

IX

The name of the unincorporated association which is being incorporated is CALVARY COMMUNITY CHURCH.

IN WITNESS WHEREOF, the undersigned being the Chairman of the Board and Secretary, respectively, of the existing unincorporated association which is being incorporated herein, have executed these Articles of Incorporation this 13 day of June, 1977.

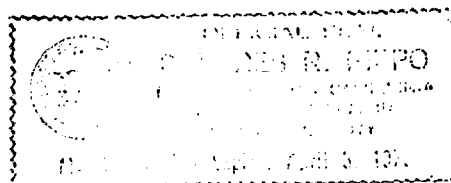

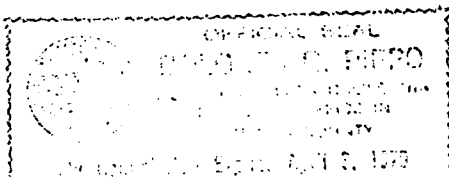
