Paul Libovitz, 2822 NE 187<sup>th</sup> Street, Aventura, FL 33180, a U.S. citizen, is the sole member of PLLW, LLC, which holds 50% of the membership interests of Waterloo TV Group, LLC, which in turn holds 100% of the membership interests of Waterloo TV Licenses, LLC, licensee of KWWF-TV, Waterloo, IA (Fac. ID: 61595). Paul Libovitz is also the Manager of Waterloo TV Group, LLC. Simultaneously with the filing of the instant application, Waterloo TV Licenses, LLC is filing an application for transfer of control of Waterloo TV Group, LLC, by which PLLW, LLC will transfer all 35% of the membership interests of Waterloo TV Group, LLC to Pegasus Minority Media, LLC (see below) and 15% of the membership interests of Waterloo TV Group, LLC to PLLW Waterloo, LLC, whose sole member is PLLW, LLC. Upon obtaining FCC consent to the transfer of control, PLLW Waterloo, LLC will hold 15% of the membership interests in Waterloo TV Group, LLC.
