

Description of Transaction

This application requests FCC consent to the *pro forma* assignment of the KXVO(TV) license from Mitts Telecasting Company (“Company”) to Mitts Telecasting Company, LLC (“LLC”). The proposed *pro forma* assignment arises from an internal reorganization that simply reflects a change from a corporate form to a limited liability company form.

Dr. Thomas F. Mitts holds 100% of the voting rights and 100% of the equity interests in both the assignor and assignee. Dr. Mitts will continue to maintain ownership and control of KXVO(TV). The proposed reorganization therefore does not represent a substantial change in ownership or control, and, as such, it involves merely a *pro forma* assignment of an FCC license.

The parties have not exchanged any consideration in connection with, and there are no written or oral agreements respecting, this internal reorganization.
