

USE OF FORM 316

Use of Form 316 is appropriate for consent to the transfer of control of Saint Michael's College, the licensee of noncommercial educational station WWPV-FM, Colchester, Vermont, FCC Facility ID Number 58598, from the former Board of Trustees to the current Board of Trustees. This application is being submitted because incrementally, over time, a majority of the Board of Trustees has changed from the membership of the Board in place at the last renewal of the license to operate WWPV-FM. *See* FCC File Nos.
