WVSC(FM) Channel 276C3 – Port Royal, SC

This statement was prepared on behalf of Apex Media Corporation ("Apex"). Apex is proposing to modify the license of WVSC, Facility ID# 49910, Channel 276C3, licensed to Port Royal, SC, and as such a Radio Market analysis is required.

WVSC is not licensed to a metro county in any Nielsen Audio ratings market. Therefore, a contour overlap study for stations not licensed to metro counties is necessary. Apex also owns WLHH, Facility ID# 40705, Channel 285C3, licensed to Ridgeland, SC with pending application BPH-20170816AAZ for Channel 285C2 at Ridgeland, SC and construction permit BPH-20161020ABE for WALI, Facility ID# 25206, Channel 229C3, Burton, SC. Apex does not own or have an attributable interest in any other radio stations which overlap principal community contours with WLHH, WVSC or WALI. The combined FCC F(50,50) 70 dBu contours of WLHH, WVSC and WALI comprises the Defined Radio Market. The WLHH FCC F(50,50) 70 dBu used for this study is for the proposed Channel 285C2 facility. The Defined Radio Market is shaded in blue on the attached map. The three subject FM station FCC F(50,50) 70 dBu contours are blue. The FCC F(50,50) 70 dBu contours of overlapping FM stations are shown in red. The 5.0 mV/M AM daytime contours of shown are shown in black. There are 23 full power AM and FM stations whose principal community contours overlap with the three subject stations. Therefore there are a total of 26 full power AM and FM commercial and non-commercial stations in the Defined Radio Market. All stations are listed on the Table of Stations Shown which is included with this exhibit. FCC Rule §73.3555(a)(1)(iii) states that in a radio market with 15

to 29 full power commercial and non-commercial stations, ownership of up to six stations with no more than four in any one band is permitted. Apex owns or has interest in only three full power FM stations in this designated market. Therefore it is believed that the proposed modification of WVSC is in compliance with §73.3555(a)(1) of the Commission's rules.



