Each of the above-listed officers and directors of JCI holds shares representing less than five percent of the votes of JCI.

JCI has three classes of stock: Class A, Class B and Class C common stock. Class A shares are traded on the New York Stock Exchange (“NYSE”). Class B and Class C shares are not traded on the NYSE. As of December 31, 2006, current and former employees of JCI and its affiliated entities collectively hold Class B shares representing 57.03 percent of the votes of JCI. As of December 31, 2006, multiple holders of the publicly-traded Class A common stock hold shares representing in the aggregate 20.31 percent of the votes of JCI.

Based on publicly filed information, as of December 31, 2006, Matex Inc. (“Matex”), a Wisconsin corporation, the address of which is 111 East Kilbourn Avenue, 19th Floor, Milwaukee, Wisconsin 53202, holds 3,033,963.023 Class C JCI shares, representing 2.56 percent of the votes of JCI, and 4,631,000 Class B JCI shares, representing 19.54 percent of the votes of JCI. Based on information supplied by Matex, applying a multiplier, as specified in Note 2(c) to Section 73.3555 of the Commission’s Rules, no shareholder holds shares of Matex representing the equivalent of 5 percent or more of the votes of JCI. The directors of Matex (who are also officers of Matex, with the specified titles), and their city and state of residence, are: Grant D.

Abert, Hillpoint, Wisconsin (Director, Vice President), David G. Meissner, Grafton, Wisconsin (Director, President, Treasurer), Donald C. Meissner, Milwaukee, Wisconsin (Director, Vice President), Linda Meissner, Fremont, California (Director, Vice President), Paul F. Meissner, Shorewood, Wisconsin (Director, Assistant Secretary), Barbara Abert Tooman, Grafton, Wisconsin (Director, Vice President) and Nancy Ward, Boulder, Colorado (Director, Vice President). There is one officer of Matex, Joseph E. Tierney III, Milwaukee, Wisconsin (Secretary), who is not also a director of Matex. Matex engages in non-media business enterprises in addition to holding stock in JCI and is not itself an FCC licensee. Based on information provided by Matex, all of the officers and directors of Matex are U.S. citizens, all possess the qualifications to be parties to an FCC licensee and none has any other reportable media interests besides those through Matex's stock holding in JCI.

Other than Matex, no party holds shares representing five percent or more of the votes of JCI, nor is any party attributable pursuant to the Commission's equity debt plus policy.
