CHANGE OF AUTHORIZED COMMUNITIES STATEMENT  
LAKESIDE, MONTANA 232C1  
BIG CAT BROADCASTING, LLC

The applicant, Big Cat Broadcasting, LLC, seeks to minor change its city of license (facility I.D. 183365) from Browning, Montana on channel 234C2, to Lakeside, Montana on channel 232C1.

The minor change of the city of license is pursuant to the provisions of MB Docket 05-210 which became effective on January 19<sup>th</sup>, 2007. This docket allows for city of license changes, under certain provisions, to be filed as a minor change application on FCC form 301 for AM and FM broadcast stations.

Big Cat Broadcasting, LLC believes this application meets the provisions under this new docket for a change in authorized communities for this new station. The docket emphasizes the desire to avoid any losses of service to communities while providing the most efficient usage of spectrum. This new allotment was acquired in auction 79 but has not yet been constructed. Therefore, if the authorized community is changed from Browning, Montana to Lakeside, Montana, Browning will experience no actual loss of service from what it is currently receiving and will continue at its present service level of 7 primary signals from stations in other communities. The proposed new community, Lakeside, Montana, does not have a commercial AM, FM, or TV station authorized to it. Therefore, it will be the community's first local service. According to the 2000 U.S. Census, the population of Lakeside was 1679. Meanwhile, the 2000 U.S. Census shows the population of Browning was 1065, having declined almost 9% since the 1990 U.S.

Census of 1170. Thus, Lakeside is more than 57% larger in population than Browning and Browning has actually decreased in size. Thus, the public interest supports a change of allotments from Browning, which will remain at its current licensed service level, while Lakeside will benefit from its first local service.

Under the Instructions for the FCC form 301, under item 18, it calls for the following information to be included:

- 1) If new technical facilities are proposed, the area and population with the proposed 70 dB $\mu$  and 60 dB $\mu$  contours of the station: In this case, the proposed contours for the proposed station at Lakeside will be: 60 dB $\mu$ : 93,793 persons and an area of 9,360 sq. km, 70 dB $\mu$ : 80,342 persons and an area of 4,156 sq. km.
- 2) The number of stations licensed to the proposed new community of license: There is no commercial AM, FM, or TV station licensed to Lakeside, Montana. This will be the community's first local service.
- 3) The number of stations providing protected service to the proposed community of license: There are 11 commercial and 1 noncommercial educational FM stations that cover the new community with 60 dB $\mu$  service or greater. There are 5 AM stations that cover the new community with 0.5 mV/m coverage or greater.
- 4) The population, according to the latest Census Data, of the proposed community of license: In this case, the community of Lakeside, Montana, is 1,679 persons according to the 2000 U.S. Census data.
- 5) Where relevant to establish the precondition of a licensable community, a description of the civic, cultural, religious, social and commercial attributes of the proposed community of license: In this case, the proposed community of license,

Lakeside, Montana, is a census designated place and has its own post office with the zip code of 59922. Utilities are provided by Flathead Electric Cooperative and Lakeside County Water & Sewer. As far as medical, Lakeside is served by the Lakeside Qru/Ambulance and the Lakeside Family Health Center. Lakeside has more than 4 churches, 2 banks, 4 motels, and a number of restaurants including: Rosario's, Homestead Cafe, Tamarack Brewing Company, Spinnaker Casino Bar & Grill, and Docks Restaurant Bar Pizzeria. Lakeside is home to the Lakeside Elementary School and the West Shore Community Library. It has its own Chamber of Commerce and a number of businesses including: Corvel Corporation, Lakeside Chiropractic Clinic, West Shore Property Management, City Market & Deli, Great Northern Veterinary Center, Lakeside Family Dentistry, U.S. Dental, Wild West Plumbing Heating & Drain, Affinity Carpet Cleaning, Wild Wave Water Craft & Boat Rental, Lakeside Coffee Company, Blacktail Grocery, and the Lakeside Gym.

- 6) Any other information deemed relevant: Helicopter scenic tours are available from Kruger Helicopters.
